STATE OF MAINE.

RESOLVE relating to the Documentary History of Maine.

Resolved, Whereas, the Maine Historical Society proposes

- 2 to publish annually a volume in a series of volumes contain-
- 3 ing the earliest documents, charters and other state papers
- 4 illustrating the history of Maine; and, whereas the funds
- 5 of the society derivable from its annual income are insuffi-
- 6 cient for this purpose; and, whereas, other states have, at
- 7 great expense, procured and published their documentary
- 8 history at the public expense; therefore,

Resolved, That the governor and council are hereby author-

10 ized to enter into contract with the Maine Historical Society

II to afford encouragement in aid of such publication, and to

12 subscribe for, or caused to be published in concurrence with

13 said society, the same number of copies as of the annual

14 volume of acts and resolves, not, however, to exceed one 15 thousand copies in all, and to be distributed in the same 16 manner; the said volumes to be properly edited with suit- 17 able notes by said society without expense to the state; pro- 18 vided, that the whole number of volumes annually printed 19 and distributed for the use of the state shall not exceed the 20 price of two dollars per volume, of not less than five hun- 21 dred pages each, with suitable indexes and proper bind- 22 ing.

Resolved, That all copies not required for distribution, in 24 compliance with existing laws, as provided in this resolve, 25 shall be deposited for safe keeping in the state library, and 26 subject to the further disposition of the legislature.

Resolved. That the sum of four thousand dollars be and 28 hereby is appropriated for the purpose of carrying out this 20 resolution, the said sum to be expended under the direction 30 of the governor and council, as herein provided.

STATEMENT OF FACTS.

The legislature of 1905 appropriated the sum of \$2,000 for the purposes described in the accompanying resolve. The two volumes of this history were delayed in the printer's hands and could not be completed before the close of the fiscal year. The appropriation for 1905 and 1906 was therefore lost. The Maine Historical Society has now completed these two volumes and is preparing to publish two additional volumes, one for the year 1907 and one for the year 1908, making a total of four volumes, consequently the appropriation asked for is \$4,000 instead of \$2,000 to cover the four volumes for the years 1905, 1906, 1907 and 1908; \$1,000 each. The historical society has already expended the first \$2,000 which was appropriated by the legislature of 1905 but has not received it from the state. This work is progressing and will be of permanent value to all historians and persons interested in the early history of Maine.
