# STATE OF MAINE.

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to incorporate the Lincolnville Water Power Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. J. P. Cilley, Lewis Pitcher, E. M. Coleman, I. 2 H. Griffin and E. A. Butler, their associates, successors and 3 assigns, are hereby made a body corporate by the name of 4 the Lincolnville Water Power Company, with all the powers, 5 rights and privileges and subject to all the duties and obliga-6 tions conferred and imposed on corporations by iaw, except 7 as otherwise provided herein.

Section 2. The purposes of said corporation are the 2 making, selling distributing and supplying electricity or 3 compressed air, or both, for lighting, heating, manufacturing

4 or mechanical purposes in the towns of Lincolnville and 5 Northport; and to repair and improve the dam at the foot 6 or outlet of the Pitcher Pond, the Tilden Pond and the 7 Andrews Pond on the Duck Trap Stream, and to erect other 8 dams on said Duck Trap Stream, to build mills and engage 9 in the manufacture of lumber and wood products and to 10 manufacture any other products including the quarrying, 11 crushing and polishing of granite, lime-rock and marble, and 12 the manufacture of cement, artificial stone, sand bricks and 13 similar building material, with all the rights, privileges and 14 powers, and subject to all the restrictions and liabilities to 15 corporations of a similar nature.

And for said purposes said company is hereby authorized 17 and empowered to acquire by lease or purchase land and 18 necessary material to build said dams and the right to flow 19 contiguous land so far as necessary to raise suitable heads 20 of water.

Sect. 3. The capital stock of said corporation shall be one 2 hundred thousand dollars, divided into shares of twenty-3 five dollars each.

Sect. 4. Said corporation is hereby empowered to set poles 2 and extend wires and lay its pipes and construct and main-3 tain its lines in, upon, along, over, across and under the 4 roads and streets of said towns of Lincolnville and North-5 port for the purpose of furnishing electric lights and com-6 pressed air for manufacturing or mechanical purposes, for 7 public and private use in said towns under such reasonable 8 restrictions as may be imposed by the municipal officers 9 thereof, subject to the general laws of the state regulating 10 the erection of posts and lines and laying pipes for the pur-11 poses of electricity and compressed air.

Sect. 5. Said corporation is hereby authorized to make 2 contracts with said towns of Lincolnville and Northport and 3 with other corporations and individuals for the purpose of 4 supplying electricity and compressed air and power as con-5 templated by this act, and said towns by their selectmen and 6 other corporations are hereby authorized to enter into con-7 tracts with said company for supplying of electricity or com-8 pressed air for light and power and for such exemptions 9 from public burdens as such towns and such corporations 10 and said company may agree upon, which when made, shall 11 be legal and binding upon all parties thereto.

Sect. 6. Said company, at its own expense. without unnec-2 essary delay shall remove any and all obstructions in any 3 street or way made in erecting or laying the lines for said 4 purpose, and cause the earth disturbed to be properly 5 replaced. It shall not be allowed to obstruct or impair the 6 use of any public or private drain or gas pipe, sewer, tele-7 graph, telephone or railroad wire, but may cross, or when 8 necessary, change the direction of any private wire or pipe, 9 drain or sewer, in such manner as to not obstruct or impair 10 the use thereof, being responsible to the owner or other 11 person for any injury occasioned thereby in an action on the 12 case.

Sect. 7. Said corporation may issue its bonds upon such 2 rates and time as it may deem expedient and in such amounts 3 as may be required for the objects of its incorporation and 4 for the purposes of this act, and secure the same by mort-5 gage upon the franchise and property of said company.

Sect. 8. The first meeting of said corporation may be 2 called by written notice thereof signed by any two corpora-3 tors herein named, served upon each corporator by a copy of 4 the same in hand or mailed postage paid, at least seven days 5 prior to the day named therein for such meeting.

Sect. 9. This act shall take effect when approved.
