
IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to incorporate the Searsport Electric Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Daniel C. Nichols, Edward D. P. Nickels,
- 2 Amos Nichols, Frank I. Pendleton, Benjamin F. Colcord,
- 3 Augustus J. Nickerson, Edward C. Pike, Frank E. Whit-
- 4 comb, Isaac H. Havner, William H. Goodell, their associates,
- 5 successors and assigns, are hereby made a body corporate
- 6 by the name of the Searsport Electric Company.
 - Sect. 2. The purpose of said corporation shall be to make,
- 2 generate, sell, distribute and supply electricity in the towns
- 3 of Searsport and Stockton Springs in accordance with the
- 4 general laws governing that business.

- Sect. 3. The capital stock of said corporation shall be fifty 2 thousand dollars divided into shares of one hundred dollars 3 each of such classes as the shareholders may determine. The 4 amount of said capital stock may be increased as found necessary from time to time in accordance with the provisions of 6 law.
- Sect. 4. Said corporation may issue bonds in such amounts 2 as may be required and secure payment thereof by mortgages 3 upon its franchises and property. Said bonds may be made 4 payable serially or on such time as the corporation may 5 decide not exceeding thirty years from dates of issue.
- Sect. 5. Said corporation is authorized to acquire by pur2 chase capital stock, plants, property, franchises, rights, priv3 ileges and locations of other corporations, associations or
 4 individuals engaged in the electric business in the towns
 5 mentioned and said parties are authorized to convey as afore6 said to said Searsport Electric Company and after the
 7 acquisition of any such property said Searsport Electric Com8 pany shall have, hold, enjoy and exercise the same for its
 9 own uses and purposes as though originally granted to it.
 Section 6. This act shall take effect upon its passage.
