STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to amend section two of chapter fifty-eight of the Private and Special Laws of 1887, as amended by chapter sixty-seven of the Private and Special Laws of 1891, relating to the Buckfield Village Corporation.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section two of chapter fifty-eight of the Private

- 2 and Special Laws of 1887 as amended by chapter sixty-seven
- 3 of the Private and Special Laws of 1891, is hereby amended
- 4 by striking out the word "and" in the fifteenth line of said
- 5 section, and by inserting after the word "farm" in said fif-
- 6 teenth line the words 'the Ernest Damon farm, the Martha
- 7 Holland stand, the B. A. Hutchinson farm and the Mary
- 8 Hall farm,' so that said section shall read as follows:

Said corporation is hereby invested with power, 10 at any legal meeting called for the purpose, to raise such II sums of money as may be sufficient for purchase, repair and 12 preservation of one or more fire engines, engine-houses, hose, 13 buckets, hooks, ladders or other apparatus for the extinguish-14 ment of fire; and for organizing and maintaining within its 15 limits an efficient fire department, also for the support and 16 maintenance of public and free high schools, within said 17 corporation, and lighting the streets; provided, however, 18 that the territory embraced within the limits of the William 10 F. Robinson farm, the Solon C. Tuttle farm, the E. C. 20 Record farm, the Silas Shaw farm, the Captain Jenkins 21 stand, and the B. H. Record farm all situated east of Hall's 22 Bridge, so called, the R. B. Waite farm, the N. T. Shaw 23 farm, the Cyrus Dean farm, the Ephriam Lowe farm, the 24 Ernest Damon farm, the Martha Holland stand, the B. A. 25 Hutchinson farm and the Mary Hall farm, together with all 26 personal property belonging on the same, and the occupants 27 thereof are hereby exempted from the provisions of this act 28 except for money raised for educational purposes.'
