STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to provide a salary for the judge of the municipal court of Dexter.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section fourteen of chapter two hundred and sixty of the 2 Private and Special Laws of eighteen hundred and eighty-3 three, is hereby amended, as follows: By striking out all 4 of said section after the word "suit" in the ninth line of 5 said section and inserting in its place thereof the following: 6 'And the said judge shall receive as full compensation for 7 his services including the keeping of the records of said 8 court and for providing all necessary blanks for the use of 9 said court, a salary of five hundred dollars a year to be paid 10 quarterly from the treasury of the county of Penobscot. 11 A condition preceding the payment of said salary as afore-

12 said, shall be the rendering by said judge of a correct and
13 detailed statement to the county commissioners and the
14 payment over by said judge to the county treasurer, of all
15 fees both civil and criminal collected by said municipal court
16 for the preceding quarter or fractional part thereof.' So
17 that said section as amended, shall read as follows:

'Sect. 14. The judge of said court may demand and 10 receive the same fees allowed to trial justices for like serv-20 ices, except that he may demand and receive for a complaint 21 and warrant in criminal cases, one dollar; for the entry of 22 a civil action, fifty cents; and for the trial of an issue, civil 23 or criminal, two dollars for the first day and one dollar for 24 each day after the first occupied in such trial, to be paid 25 to him by the plaintiff in civil cases, before trial, who shall 26 recover the same as costs if he prevail in the suit; and the 27 said judge shall receive as full compensation for his services 28 including the keeping of the records of said court, and for 29 providing all necessary blanks for the use of said court, a 30 salary of five hundred dollars a year, to be paid quarterly 31 from the treasury of the county of Penobscot. A condition 32 preceding the payment of said salary as aforesaid, shall be 33 the rendering by said judge of a correct and detailed state-34 ment to the county commissioners, and the payment over 35 by said judge to the county treasurer, of all fees, both civil 36 and criminal, collected by the said municipal court for the 37 preceding quarter or fractional part thereof.'
