## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to incorporate the Princeton and Grand Lake Stream
Steamboat Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Charles F. Eaton, Alice M. Eaton, C. A.

- 2 Rolfe, S. L. Peabody and John McCann, all of Princeton,
- 3 in the County of Washington, or such of them as may by
- 4 vote accept this charter, with their associates, successors
- 5 and assigns, are hereby made a body corporate and poli-
- 6 tic, to be known as the Princeton and Grand Lake Stream
- 7 Steamboat Company, and as such shall be possessed of all
- 8 powers, privileges and immunities, subject to all the duties
- 9 and obligations conferred on corporations by law.
- Sect. 2. The corporation hereby created shall be located 2 at Princeton, Washington County, Maine.

Sect. 3. Said corporation is hereby granted the right 2 to navigate the waters of Leweys Lake, Long Lake and 3 Big Lake and tributaries thereto, together with the Nar-4 rows, Basin Narrows and Indian Point Narrows, so called, 5 connecting said lakes, all in the County of Washington, said 6 state, with boats or vessels propelled by steam or electricity, used for the carriage of passengers and freight for 8 hire, together with the right to tow logs, wood and timber 9 for hire, for the term of ten years from the passage of this 10 act; provided, that the said corporation, its successors or 11 assigns, furnish reasonable accommodations for the trans-12 portation of passengers or freight upon said lakes, tributaries and connections during the summer season.

Sect. 4. Said corporation shall have the right to place 2 buoys within said lakes, streams and connections as may 3 aid in navigating the same, together with the right to erect 4 wharves on its own land and extend the same into said 5 lakes, streams and connections as may be necessary with-6 out obstructing the navigation of said lakes, streams and 7 connections for log driving and other purposes.

Sect. 5. The capital stock of said corporation shall be 2 twenty-five thousand dollars, divided into shares of fifty 3 dollars each, any portion of which stock as said corporation may determine may be known as treasury stock and 5 remain in the treasury of said corporation. All the rights 6 of the aforesaid corporation, its successors or assigns, 7 under the provision of this act shall cease and terminate 8 whenever said corporation, its successors or assigns, shall 9 fail to perform its duties for the reasonable space of thirty 10 days from the receipt of a reasonable notice so to do.

Sect. 6. Any one of the corporators named in this act 2 may call the first meeting of the corporation by mailing a 3 written notice, signed by him, postage paid, to each of 4 the other corporators, seven days at least before the day of 5 the meeting, naming the time and place and purpose of 6 said meeting, and at such meeting the necessary officers 7 may be chosen, by-laws adopted and other corporate busi-8 ness transacted.

Sect. 7. This act shall take effect when approved.
