STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVEN.

AN ACT authorizing the Island Ferry Company to construct a
wharf and ferry slip into the waters of Casco Bay.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. Whenever authorized by the secretary of war,
2 the Island Ferry Company, a corporation organized and
3 existing under the laws of this state, its successors or assigns,
4 is hereby authorized and empowered to erect and maintain
5 a wharf, pier and ferry slip on the northwesterly shore of
6 Peak's Island in Casco Bay, and extend the same into the
7 tide waters of said bay and connect the same with any pub-
8 lic street or way laid out on said island to low water mark

9 in such a manner as may be necessary to accommodate the
10 public in travelling over said way to reach its wharf, pier,
11 ferry slip or boats, first obtaining the consent of the city
12 council of the city of Portland to erect such structures as
13 may be necessary within the limits of said way to render its
14 ferry slips and boats accessible over said way.

Sect. 2. The city of Portland is hereby authorized to
2 grant to said Island Ferry Company, its successors or
3 assigns, upon such terms as its city council may impose, the
4 right to construct a pier or such necessary structures within
5 the limits of any street or way on Peak's Island between
6 high and low water mark as may be necessary to render any
7 wharf or ferry slip it may construct under this act accessible
8 to the travelling public over said street or way, the said
9 company first obtaining the consent (of the commissioners
10 of harbor and tidal waters of the city of Portland and) of
11 the secretary of war before commencing the erection of such
12 structures.

Sect. 3. The order of the city council of the city of Port-
2 land duly approved by the mayor of said city on the fourth
3 day of February, A. D. 1907, in relation to a contract
4 between said city of Portland and said Island Ferry Com-
5 pany and the agreement entered into between said city of
6 Portland and said Island Ferry Company in accordance
7 with the terms of said order, are hereby ratified and made
8 valid and binding upon the parties thereto.

Sect. 4. This act shall take effect when approved.
