STATE OF MAINE.

RESOLVE in favor of the town of Frenchville, in the county of Aroostook, to assist in building a road in said town.

Resolved, That the sum of two hundred dollars be and
2 hereby is appropriated for the year nineteen hundred and
3 seven, to aid in building a road in the town of Frenchville.
4 Provided, that said town of Frenchville furnishes at least
5 four hundred dollars of its own money towards building
6 said road, the same to be expended under the direction of
7 an agent appointed by the Governor and Council. Said
8 amount to be paid upon certificate of said agent to the
9 Governor and Council that the road is completed, and that
10 the town of Frenchville has expended at least four hundred
11 dollars of its own money towards building said road.

STATEMENT OF FACTS.

This road would open a market to about one hundred and fifty people and connect them with the highway road running from Fort Kent to Van Buren. It runs in a northerly direction for a distance of about one mile and one-half in the woods and crosses a brook twice, where bridges will have to be built at great expense. The town will pay the balance required to build those bridges and furnish the road, if the State furnishes two hundred dollars towards building same.

To the Honorable Senate and House of Representatives assembled:

We, the undersigned citizens of the town of Frenchville, hereby ask your honorable body, that the sum of two hundred dollars be appropriated in aid in building a road from Henry Rossignol to Audule Marquis.
