STATE OF MAINE.

SENATE AMENDMENT "A" TO HOUSE DOCUMENT NO. 346.

Amend section nine of House Document number three
2 hundred forty-six by adding after the word "lease" in the
3 first line thereof the words 'or sell' and by adding after the
4 words "acquired" in the tenth line of said section the words
5 'The Somerset Traction Company, a corporation organized
6 by special act of the legislature of Maine, is hereby author-
7 ized to acquire by purchase the rights and franchises of said
8 Fairfield and Skowhegan Railway Company on such terms
9 as it may determine and to consolidate the same with said
10 Somerset Traction Company so that it may form one com-
11 pany, so that said section as amended shall read as follows:

'Sect. 9. Such corporation is hereby authorized to lease
13 or sell all of its property and franchises on such terms as
14 it may determine, also to consolidate with or to acquire by

15 lease, purchase or otherwise, the lines, property and fran-
16 chises of any other street railway, whose lines as con-
17 structed or chartered would form connecting or continuous
18 lines with the lines of this company, and in such case this
19 corporation shall be entitled to all the privileges, and be
20 subject to all appropriate conditions and limitations con-
21 tained in the charter thus united with or acquired. The
22 Somerset Traction Company, a corporation organized by
23 special act of the legislature of Maine, is hereby authorized
24 to acquire by purchase the rights and franchises of said
25 Fairfield and Skowhegan Railway Company on such terms
26 as it may determine and to consolidate the same with said
27 Somerset Traction Company so that it may form one com-
28 pany. Whenever any person or corporation shall be law-
29 fully operating any street railway to any point to which
30 this corporation's tracks extend, this corporation may enter
31 upon, connect with and use the same on such terms and in
32 such manner as may be agreed upon between the parties.'

SENATE AMENDMENT "B" TO HOUSE DOCUMENT
NO. 346.

Amend House Document number three hundred forty-six
2 by adding after section fourteen the following:

'Sect. 15. The first meeting shall be called by one or
4 more of the incorporators by giving notice thereof stating
5 the time, place and purpose of the meeting to each incor-
6 porator in writing, or by publishing in some newspaper
7 printed in the county of Somerset, at least fourteen days
8 prior to the time appointed therefor.'

SENATE AMENDMENT "C" TO HOUSE DOCUMENT
NO. 346.

Amend House Document number three hundred forty-six
2 by striking out the figures "15" after the word "Section"
3 in section fifteen in the first line and inserting in place there-
4 of the figures '16.'
