STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVEN.

AN ACT additional to and amendatory of chapter three of the
Private and Special Laws of the year eighteen hundred and
eighty-seven entitled "An Act to supply the people of the
town of Presque Isle with pure water."

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. Section two of said act is hereby amended so
2 that said section two as amended shall read as follows:

'Sect. 2. Said corporation may for said purposes hold real
4 and personal estate not exceeding one hundred thousand dol-
5 lars.'

Sect. 2. Section five of said act is hereby amended so that
2 said section five as amended shall read as follows:

‘Sect. 5. Said corporation may make contracts with the
4 United States of America, the state of Maine, the county of
5 Aroostook, the town of Presque Isle, with any other town
6 in the county of Aroostook, the Presque Isle Village Fire
7 Department, any corporation, public or private in said county
8 of Aroostook, and with individuals in said town of Presque
9 Isle, and in any other town in said county, for supplying
10 water for any and all public and private purposes and espe-
11 cially for the extinguishment of fires, and may from time to
12 time fix and establish reasonable rates for the use of water
13 supplied as aforesaid, and receive and collect said rates from
14 the towns, corporations, firms, persons and individuals with
15 whom such contracts are made. The said town of Presque
16 Isle and any other town in said county, by a majority vote
17 of its legal voters present and voting thereon at any legal
18 meeting called for the purpose, may authorize and empower
19 its selectmen to contract in the name of the town with said
20 Presque Isle Water Company, for any term of years, for a
21 supply of water for the extinguishment of fires and for any
22 other purpose. The Presque Isle Village Fire Department,
23 by a majority vote of its legal voters present and voting
24 thereon at any legal meeting called for the purpose, may
25 authorize and empower its directors to contract in the name
26 of said department with said Presque Isle Water Company,
27 for any term of years, for a supply of water for the extin-
28 guishment of fires and for any other purpose.’

Sect. 3. This act shall take effect when approved.
