STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVEN.

AN ACT to regulate ice fishing in certain lakes and ponds and
streams in Aroostook, Penobscot and Piscataquis Counties.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. It shall be unlawful to fish for, take, catch or
2 kill any kind of fish on or through the ice in the following
3 named lakes, ponds and streams in the county of Aroostook,
4 to wit, in Big Fish lake, Portage lake, St. Froid lake, Eagle
5 lake, Square lake, Cross lake, Mud lake, Salmon lake and
6 all brooks, streams or thoroughfares connecting the same.

Sect. 2. It shall be unlawful to fish for, take, catch or
2 kill any kind of fish through the ice in Millmegasset lake or

3 adjoining ponds, situated in the county of Penobscot, or in
4 any of the lakes or ponds on Millinockett stream and tribu-
5 taries, situated in Piscataquis county, or in any of the lakes
6 or ponds on Munsungan stream and its tributaries, situated
7 in Piscataquis county, or in any of the lakes or ponds on
8 Mooseleuk stream and its tributaries, in the counties of
9 Piscataquis and Aroostook, or in any of the lakes or ponds
10 on Lepompeog stream and its tributaries, in the counties of
11 Penobscot and Aroostook, or in any of the lakes or ponds
12 on Umcolcus stream and its tributaries, situated in the coun-
13 ties of Aroostook and Penobscot.

Sect. 3. Whoever violates any of the provisions of this
2 act shall be subject to a penalty of not less than ten dollars
3 nor more than thirty dollars and costs for each offense and
4 a further penalty of one dollar for each fish taken, caught,
5 killed or had in possession in violation of the provisions of
6 this act.
