## STATE OF MAINE.

RESOLVE relating to title and sale of gun house in Kittery,  
York county, formerly used by Company "B" Artillery, First  
Regiment Maine Volunteer Militia.

---

*Resolved,* That the governor and council is hereby author-  
2 ized and empowered to cause to be conveyed to the town of  
3 Kittery in York county, in consideration of one dollar, all  
4 the rights, title and interest which the state of Maine has or  
5 may have in the old gun house in Kittery, York county,  
6 formerly used by Company "B" Artillery, first division,  
7 Maine Volunteer Militia and the lot on which the same  
8 stands.



## STATEMENT OF FACTS.

The Standing Committee on Military Affairs, to which was referred the deed of William Mason of Kittery, to the state of Maine, and the communication of M. F. Wentworth, asking for the appropriation for a "gun house at Kittery," have had the same under consideration and report: That the governor be advised to draw his warrant on the treasurer of state, in favor of M. F. Wentworth, for the sum of six hundred dollars, pursuant to a resolve approved April second, eighteen hundred and fifty-nine. To be paid from and charged to the appropriation for a "gun house at Kittery," under act of April fourth eighteen hundred and fifty-nine.

## CHAPTER 269.

Resolve providing for the erection of a gun house in Kittery

Resolved, That the governor with the consent of the council is hereby authorized to pay or cause to be paid out of the state treasury, the sum of six hundred dollars to such person or persons as they may direct, for the purpose of aiding the members of the B company of artillery, in the first division of Maine Volunteer Militia, in the erection of a suitable building to be used for a place of safe deposit of the ordnance and ordnance apparatus and other property committed by the state to the care of said B company, and also as a place of military drill and discipline; provided, said B company shall first convey to the state by a good and sufficient deed a suitable lot of land in the village in the town of Kittery whereon said building can be erected; and also shall produce satisfactory evidence to the governor and council that they, the members of said B company will pay or cause to be paid the sum of six hundred dollars to the person or persons designated by the governor and council, to be expended in finishing and completing said building to be used as aforesaid; and the building erected on the land conveyed as aforesaid shall belong to the state.

(Approved April 2, 1859.)
