STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to amend Chapter 222 of the Private and Special Laws of the year 1903, entitled "An Act to authorize extensions of the Bangor and Aroostook Railroad in Aroostook, Piscataquis and Penobscot Counties."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. Section I of chapter 222 of the Private and 2 Special Laws of the year 1903 is hereby amended by insert-3 ing between the words "extension" and "by" in the last line 4 but one of said section, the following words: 'and a branch 5 extending from a point of connection with the main line 6 of said railroad either in Township No. 4, Range 9, 7 N. W. P., in Piscataquis county, or Township Long A, in 8 Penobscot county, in a general southerly direction between

9 Schoodic Lake and Sebois Lake to a point of connection 10 with the main line of said railroad in the town of Lagrange," 11 so that said section as amended shall read as follows:

'Section 1. For and during a period of ten years from 13 and after the passage of this act, the Bangor and Aroostook 14 Railroad Company is hereby authorized and empowered to 15 build in one or more of the counties of Penobscot, Piscata-16 quis and Aroostook but only in that part of said counties 17 west of that part of the Bangor and Aroostook Railroad 18 which runs from Brownville to Van Buren and north of 19 that part of the Canadian Pacific Railroad which extends 20 from the west line of the State to said part of said Bangor 21 and Aroostook Railroad extensions of its railroad, and 22 extensions of any line of railroad the franchise of which 23 it may, under legislative authority acquire, and extensions 24 of such extensions and branches to connect with its said 25 railroad, and branches to connect with any railroad which 26 it may acquire as aforesaid or with any such extension, and 27 a branch extending from a point of connection with the 28 main line of said railroad either in Township No. 4, Range 29 9, N. W. P., in Piscataquis county, or Township Long A, 30 in Penobscot county, in a general southerly direction between 31 Schoodic Lake and Sebois Lake to a point of connection 32 with the main line of said railroad in the town of Lagrange, 33 by complying with the provisions of this act.'

Sect. 2. This act shall take effect when approved.
