STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVEN.

AN ACT to authorize the Twin State Gas and Electric Com-
pany to exercise certain powers in this State.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. The Twin State Gas and Electric Company,
2 a corporation existing under the laws of Connecticut, is
3 hereby authorized to exercise within this State the powers,
4 privileges, rights and franchises conferred upon it by its
5 certificate of incorporation, and such additional powers,
6 privileges, rights and franchises as are hereby conferred,
7 subject to the conditions herein contained.

Provided, however, that said The Twin State Gas and Elec-
9 tric Company shall not have authority to make, generate,

10 sell, distribute or supply gas or electricity, or both, for any
11 purpose, in or to any city or town in this state, in or to
12 which another company, person or firm are making, gener-
13 ating, selling, distributing or supplying, or are authorized
14 to make, generate, sell, distribute or supply gas or electricity,
15 or both, except those named in section two of this act, unless
16 and until it shall obtain the consent of such other company,
17 person or firm.

Sect. 2. The sale, transfer and conveyance to said The
2 Twin State Gas and Electric Company by the Dover Gas
3 Light Company of all assets, property, rights, privileges and
4 franchises of said Dover Gas Light Company is hereby
5 ratified, approved and confirmed, and said The Twin State
6 Gas and Electric Company is invested with and empowered
7 to exercise and enjoy all the powers, privileges and fran-
8 chises of said Dover Gas Light Company in the towns of
9 Lebanon, Berwick, North Berwick, South Berwick, Wells
10 and Eliot, in the county of York, subject, however, to all
11 duties and liabilities incident thereto.

Sect. 3. Said company is hereby authorized to acquire by
2 purchase, lease or otherwise the franchise, rights, property
3 and privileges, also the capital stock, of the Agamenticus
4 Light and Power Company, and said Agamenticus Light
5 and Power Company may make such sale of said franchise,
6 property, rights and privileges; and upon said purchase and
7 transfer being made, but not otherwise, said Twin State
8 Gas and Electric Company shall succeed to and may exer-

9 cise and enjoy all the rights, powers, privileges and immuni-
10 ties of said Agamenticus Light and Power Company, and
11 may sell, distribute and supply gas and electricity for light,
12 heat and power to the town of York, and the several village
13 corporations therein located, and to the inhabitants thereof,
14 and said town and village corporations are hereby author-
15 ized to contract therefor, upon said purchase being made as
16 aforesaid.

Sect. 4. The mortgage of The Twin State Gas and Elec-
2 tric Company to the Knickerbocker Trust Company, dated
3 October 1, 1906, securing an issue of one million five hun-
4 dred thousand dollars (\$1,500,000), par value, of bonds, is
5 hereby authorized, ratified and approved.

Sect. 5. All acts of municipalities conferring powers,
2 privileges or licenses on The Twin State Gas and Electric
3 Company are hereby ratified and confirmed.

Sect. 6. The Twin State Gas and Electric Company shall
2 file in the office of the Secretary of State a certificate under
3 its corporate seal designating some place in this State as its
4 principal office in Maine, and some citizen of this State as
5 an agent upon whom process from the courts of this State
6 may be served with like effect as if upon an officer thereof.
7 Whenever a vacancy occurs in said designation a new agent
8 shall be designated in the same manner, and if there be at
9 any time no such agent then service of any process may be
10 made on the Secretary of State with like effect as if made on
11 an officer of said corporation.

(Sect. 7. This act shall take effect when approved.
