## STATE OF MAINE.

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to amend chapter three hundred forty-five of the Private and Special Laws of one thousand nine hundred one, entitled "An Act to authorize the erection and maintenance of dams, side dams, piers and booms in the Sandy Stream, Gilman Pond and Gilman Stream in the plantations of Highland and Lexington and the town of New Portland in the County of Somerset and State of Maine, and to make improvements in said streams and pond."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section I. Section one of chapter three hundred forty-2 five of the Private and Special Laws of one thousand nine 3 hundred one is hereby amended by inserting after the word 4 "build" in the eighth line, the following words: 'erect and

5 maintain dams,' so that said section, as amended, shall read 6 as follows:

'Section I. Joseph C. Viles and James W. Perkins, their 8 associates, successors and assigns are hereby authorized and 9 empowered to locate, erect and maintain in Sandy stream on 10 land now owned by Bartlett and Plummer in Highland 11 plantation in the county of Somerset and State of Maine, 12 and not more than one mile below the forks of said Sandy 13 stream, a dam with which to raise a head of water to facili-14 tate the driving of logs, pulp wood and other lumber down 15 said stream; and to build, erect and maintain dams, side 16 dams, piers, rack booms, remove rocks and make other 17 improvements on said Sandy stream and its tributaries above 18 Gilman pond in Lexington plantation in said county of Som-19 erset, to facilitate the driving of logs, pulp wood and other 20 lumber down the same.'

Sect. 2. Section two of said chapter three hundred forty-2 five is hereby amended by striking out of the tenth line in 3 said section the words "rack boom" and inserting the words 4 'piers and booms,' so that said section, as amended, shall 5 read as follows:

'Sect. 2. Said Joseph C. Viles and James W. Perkins, 7 their associates, successors and assigns are also hereby 8 authorized and empowered to locate, erect and maintain in 9 Gilman pond in Lexington plantation and in the town of 10 New Portland piers and booms to facilitate the driving of 11 logs, pulp wood and other lumber across said Gilman pond;

12 also to erect and maintain across Gilman stream in said town
13 of New Portland a rack boom within one mile of the Carra14 bassett river, so called, and between land of William Parsons,
15 for the purpose of holding pulp wood in said Gilman stream.
16 Said piers and booms to be so constructed as to provide
17 prompt and convenient passage of all logs, pulp wood and
18 other lumber that may come within the same without unrea19 sonable or unnecessary delay.'

Sect. 3. Section six of said chapter three hundred forty-2 five is also hereby amended so that the same shall read as 3 follows:

'Sect. 6. The costs of all dams, side dams, piers, repairs 5 and improvements erected and made in and upon said pond, 6 streams and their tributaries by said Joseph C. Viles and 7 James W. Perkins, or either of them, and their associates, 8 successors and assigns, during and since the years one thou-9 sand eight hundred ninety-nine and one thousand nine hun-10 dred shall be included in the cost to be determined as pro-11 vided in section five of said act.'

Sect. 4. This act shall take effect when approved.
