STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVEN.

AN ACT relating to the Portland & Rumford Falls Railway
and the Rumford Falls & Rangeley Lakes Railroad Com-
pany.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. The Portland & Rumford Falls Railway is
2 hereby authorized and empowered to acquire by lease or
3 purchase the railroad, property and franchises of any rail-
4 road corporation or corporations which may now or here-
5 after form a continuous line between the city of Portland
6 in the State of Maine and Megantic in the Province of
7 Quebec, of which the railroad of said Railway is a part, and

8 any such other railroad corporation is hereby authorized and
9 empowered to make such lease or sale to said Portland &
10 Rumford Falls Railway upon such terms as may be mutu-
11 ally agreed upon.

Sect. 2. The Rumford Falls & Rangeley Lakes Railroad
2 Company is hereby authorized and empowered to acquire by
3 lease or purchase the railroad, property and franchises of any
4 railroad corporation or corporations which may now or here-
5 after form a continuous line between the city of Portland in
6 the State of Maine and Megantic in the Province of Quebec,
7 of which the railroad of said railroad company is a part, and
8 any such other railroad corporation is hereby authorized to
9 make such lease or sale upon such terms as may be mutually
10 agreed upon.

Sect. 3. Said Rumford Falls & Rangeley Lakes Railroad
2 Company is also authorized and empowered to sell or lease
3 the whole or any part of its railroad, property, or franchises,
4 including those acquired by lease or otherwise, to any other
5 railroad corporation, and any such other railroad corporation
6 may acquire any of the same by lease or purchase, or may
7 acquire any stock, bonds, or other securities issued by the
8 said Rumford Falls & Rangeley Lakes Railroad Company,
9 upon such terms as may be mutually agreed upon.

Sect. 4. This act shall take effect when approved.
