## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVEN.

AN ACT to amend the law relating to political caucuses in the City of Bangor.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section three of Chapter 497 of the Private and

- 2 Special Laws of the year 1901, is hereby amended by str.king
- 3 out of said section all words after the word "voters" in the
- 4 twenty-third line of said section, and substituting therefor
- 5 the words: 'And thereafter said board of registration shall
- 6 from time to time add to said list all names which have been
- 7 added to the list of voters, with the party designation, if any,
- 8 and shall take from said list all names which have been
- 9 stricken from the list of voters.'

Said section is also hereby amended by changing "tenth" II in the third line to 'fifteenth,' and by changing the word 12 "first" in the eighth line to 'tenth,' and by changing the 13 word "first" in the thirteenth line to 'tenth,' and by changing 14 the word "first" in the twentieth line to 'tenth,' so that said 15 section as amended shall read as follows:

'Sect. 3. The board of registration in said Bangor, as soon 17 as may be after the receipt of such assessors' list, and before 18 the fifteenth day of July in each year, shall give notice by 10 mail, of such designation to every person against whose 20 name the same appears, with notice that the same will be 21 placed upon the certified copies of the voting lists to be used 22 in caucuses as hereinafter provided, unless he requests some 23 other party designation in person or by writing, on or before 24 the tenth day of August next. Said board shall at the same 25 time so notify every person having no party designation 26 upon the assessors' lists of the fact of such omission and 27 that his name will bear no party designation upon the voting 28 lists unless he requests said board, in person or by writing 29 on or before the tenth day of August next, to make such 30 designation. In case of additions to and corrections in the 31 original assessors' list, such notices shall be issued immedi-32 ately upon receipt thereof by the said board. Said board of 33 registration shall be in public session from nine in the fore-34 noon to one o'clock in the afternoon, and from three to five 35 o'clock in the afternoon, and from seven until nine o'clock 36 in the afternoon on each of the five secular days next prior 37 to the tenth day of August of each year for the purpose of 38 making additions to said lists and changes and corrections 39 in the party designation of voters. And thereafter said board 40 of registration shall from time to time add to said list all 41 names which have been added to the list of voters, with the 42 party designation, if any, and shall take from said list all 43 names which have been stricken from the list of voters.'

Sect. 2. After the board of registration shall have made 2 the list of voters for the year 1907 with the party designation 3 as provided in Section 3 of said Act, such party designation 4 shall remain the same on that list and the lists for subsequent 5 years unless a voter in person or in writing signed by him, 6 shall request his party designation to be changed.

Sect. 3. This act shall take effect when approved.
