STATE OF MAINE.

In House of Representatives, January 27, 1909.

Ordered, That the justices of the Supreme Judicial Court

- 2 are hereby required to give to the House of Representatives,
- 3 according to the provisions of the Constitution in this behalf,
- 4 their opinion on the following question, to wit: Has the
- 5 Legislature the legal power under the Constitution of the
- 6 State of Maine to enact the following bill now pending:

"AN ACT to encourage and aid the building of a railroad through the undeveloped portion of Northern Maine.

"Be it enacted by the People of the State of Maine, as follows:

"Section 1. Provided the Bangor & Aroostook Railroad

12 Company shall, in good faith, on or before January 1, 1911,

13 commence to build a line of railroad which shall begin at

14 its present main line in the vicinity of West Sebois and

15 shall finally extend in a general northerly direction to the 16 St. John River, as the same may be legally laid out, and 17 shall commence to build a railroad into or through the 18 towns of Washburn and Perham; thereupon when said 19 Railroad Company shall commence to build such railroads, 20 said Railroad Company is hereby authorized to enter into 21 an agreement with the State of Maine, for the transporta-22 tion, over the lines of railroad which it is now operating, 23 and over any railroad which it may build, of troops and 24 munitions of war in times of war, insurrection or civil com-25 motion, free of charge other than as herein provided, until 26 January I, 1921, and to receive therefor from said State 27 annually for the term of said contract an amount which 28 shall equal ninety-five per cent of the taxes collected in 29 the corresponding year by said State upon the lines of rail-30 road which it is now operating and upon any other lines 31 of road which it may build, and upon its real and personal 32 property, including its stock and franchise.

"Whenever before January 1, 1911, the building of said 34 lines of railroad shall in good faith be commenced, there-35 upon said Railroad Company may execute such a contract 36 and present it to the Treasurer of said State, and it shall 37 be the duty of said Treasurer to execute said contract in 38 behalf of said State, and thereafter said Treasurer shall 39 pay over to said corporation each year during the term of 40 said contract the amount provided in this Act."
