## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to establish an additional Normal School to be located at Machias in the county of Washington.

### Be it enacted by the People of the State of Maine, as follows:

- Section 1. Another Normal School to be known as Wash-
- 2 ington State Normal School is hereby created and estab-
- 3 lished upon such plans as the Board of Trustees for Normal
- 4 Schools may direct.
- Sect. 2. Said Normal School shall be located at Machias
- 2 in the county of Washington, provided and upon condition
- 3 that the inhabitants of said town of Machias, shall, within
- 4 six months after the date on the approval of this act, to de-
- 5 note and cause to be conveyed to the State for the purpose

6 and use of such school a lot of land not less than five acres
7 in extent and whatever buildings stand theron may be se8 lected and approved by the said board of trustees for Nor9 mal Schools.

Said inhabitants of said town of Machias at a legal meeting II of said inhabitants called and held within six months, are 12 hereby authorized and empowered by a majority vote of the 13 legal voters voting at said meeting to authorize and direct 14 the selectmen of said town of Machias to purchase the lot 15 and buildings so selected and approved by said Board of 16 Trustees for Normal Schools, to denote said lot of land and 17 buildings to said State for the use and purpose aforesaid, and 18 to instruct and direct the said selectmen to make, execute 19 and deliver for and in behalf of said inhabitants a proper 20 deed conveying said lot of land and buildings to the State 21 for the use and purposes aforesaid. Said deed shall be de-22 livered to the Board of Trustees of Normal Schools who 23 are hereby authorized and empowered to accept and receive 24 the same for and in behalf of said State, and when so de-25 livered it shall be conclusive evidence of the legality of the 26 meeting of said inhabitants to be held as aforesaid and of the 27 proceeding at such meeting; and the title of said lot of land 28 and buildings thereon, shall be forever vested in said State 29 for the use and purposes aforesaid, and when such convey-30 ance and delivery of such deed are made, said trustees are 31 authorized, instructed and directed to procure teachers and 32 put in operation such school. The cost of maintenance of

- 33 such school shall be deducted and paid from the public school 34 fund. When so established, said school shall be under the 35 direction of said board of trustees, be conducted for the pur-
- 36 poses, and upon the Principal of the other State Normal
- 37 Schools, and be subject to all the laws of the State relating 38 to the same.
  - Sect. 3. For the purposes of this act the sum of twenty-
  - 2 five thousand dollars is hereby appropriated; such sum to be
  - 3 available only when said lot and building are donated to the
  - 4 State as provided in section two of this act.
    - Sect. 4. So much of said sum of twenty-five thousand dol-
  - 2 lars as may be necessary shall be used by said Trustees for
  - 3 repairing buildings on said lot of land the balance to be used
  - 4 in erecting any other necessary building or buildings on said
  - 5 lot.
