STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT to enable the town of Winter Harbor to purchase the property and franchise now or formerly of the Winter Harbor Gas & Light Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The municipal officers of the town of Winter
2 Harbor in Hancock County when thereto directed by vote of
3 said town, are authorized and empowered for and in behalf
4 of said town to purchase the whole of the system of gas
5 lighting formerly of the Winter Harbor Gas & Light Com-
6 pany, including any property, franchises, rights and priv-
7 ileges now or formerly owned by or vested in said company,

8 or to purchase or lease any other plant or lighting system
9 for operation in said town.

Sect. 2. The Winter Harbor Gas and Light Company is
2 hereby authorized and empowered to sell and convey by
3 deeds of transfer and conveyance any and all the property,
4 franchises, rights and privileges, owned by said Winter Har-
5 bor Gas and Light Company to said town of Winter Har-
6 bor, or to such person or persons in trust for the benefit of
7 said town as the municipal officers of said town may desig-
8 nate; and if the municipal officers of said town shall desig-
9 nate that said property, franchises, rights and privileges,
10 shall be conveyed to any person or persons in trust, as afore-
11 said, they shall also designate the terms of said trust which
12 shall be incorporated in said deed. When said conveyance
13 is made as aforesaid, and delivered to said town, or trustee,
14 the town shall thereupon, enter into possession and control
15 of the property, rights, franchises and privileges therein
16 transferred, subject to be divested thereof upon failure to
17 carry out the purpose and object of the creation of the Win-
18 ter Harbor Gas and Light Company.

Sect. 3. The town of Winter Harbor is hereby authorized
2 and empowered to raise money for the purposes of this act,
3 and may, to carry out the provisions hereof, issue its nego-
4 tiable notes, in behalf of said town, signed by the municipi-
5 pal officers of said town, when authorized by vote of said
6 town.

Sect. 4. The municipal officers of said town of Winter
2 Harbor shall constitute a board of commissioners to perform
3 all acts for the town consistent with this act, subject to such
4 conditions as the town may by vote impose.
