STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT amending and extending the provisions of Chapter 375, Private and Special Laws of 1905, entitled An Act to Authorize the Town of Castine to construct for itself and for persons and corporations a system of Water Works in said town.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section 8 of said act is hereby amended by 2 striking out the words "Aqueduct" in the sixth and eighth 3 lines and inserting instead thereof the words 'Acadia Aque- 4 duct,' so that said Section 8 shall read as follows:

'Section 8. Said town is hereby authorized to purchase, 6 and the Castine Water Company is hereby authorized to con- 7 vey, any or all of the stock or bonds of the Castine Water

8 Company and any or all of the rights, property, franchises
9 and privileges of said Castine Water Company. Said town
10 is also hereby authorized to purchase, and the Castine Acadia
11 Aqueduct Company is hereby authorized to convey, any or
12 all of the property, franchises and privileges of said Castine
13 Acadia Company.'

Sect. 2. Section 11 of said act is hereby amended by strik-
2 ing out the word "six" in the third line and inserting in its
3 stead the word "ten" so that said Section 11 shall read as
4 follows:

'Section 11. This act shall be null and void if the Castine
6 Water Company, on or before October thirtieth, in the year
7 nineteen hundred and ten, shall complete its system of water
8 works so as to enable it to reasonably perform the terms of
9 a certain contract made between itself and said town, dated
10 October sixth in the year one thousand eight hundred and
11 ninety-six. The determination of the question as to wheth-
12 **er said Castine Water Company has thus completed its sys-**
13 **tem shall be left to a competent engineer who shall be chosen**
14 **by any justice of the supreme judicial court, in term time or**
15 **vacation, upon application in writing made by said town or**
16 **said Castine Water Company, and the determination of said**
17 **engineer shall be final.'**
