STAFE OF MAINE.

RESOLVE, making appropriations for the Passamaquoddy Tribe of Indians.

Resolved. That there be paid from the State treasury, to 2 be expended under the direction of the governor and coun-3 cil, to the agent of the Passamaquoddy tribe of Indians for 4 the benefit of said tribe for the years nineteen hundred and 5 nine and nineteen hundred and ten, as follows:

For May dividends each year, four hundred dollars; for 7 November dividends each year, four hundred dollars; for 8 distressed poor each year, five thousand dollars; for agri-9 cultural purposes each year, six hundred dollars; for plow-10 ing each year, one hundred fifty dollars; for fertilizer each 11 year, one hundred fifty dollars; for bounty on crops each 12 year, one hundred fifty dollars; for wood each year, six hun-

13 dred fifty dollars; for contingent purposes each year, two 14 hundred dollars; for salary of priests each year, five hun-15 dred dollars-Calais priest three hundred and Eastport 16 priest two hundred; for salary of governors each year, one 17 hundred dollars; for salary of lieutenant governors each 18 year, forty dollars; for salary of agent each year, four hun-19 dred dollars; for salary of police at Pleasant Point each 20 year, one hundred dollars; for educational purposes each 21 year, twelve hundred dollars; for basket ash each year, three 22 hundred fifty dollars; for school books each year, sixty dol-23 lars; for fuel for schools and church, at Pleasant Point each 24 year, one hundred seventy-five dollars; for insurance on 25 church and homes each year, eighty dollars; for repair of 26 road at Peter Dana's point each year, one hundred dollars; 27 for repair of road at Pleasant Point for 1909 only, one hun-28 dred dollars; for repair of buildings at Peter Dana's point 29 each year, fifty dollars; for repair of buildings at Pleasant 30 Point each year, fifty dollars; for two U. S. flags for pub-31 lic buildings for 1909 only, twenty dollars; for balance due 32 for completion of water works at Pleasant Point for 1909 33 only, two hundred eighty-eight dollars; for a building to con-34 tain two school rooms and a room where sewing and cook-35 ing may be taught at Pleasant Point for 1909 only, twenty-36 five hundred dollars.

Amount for nineteen hundred and nine, thirteen thousand 38 eight hundred thirteen dollars, and for nineteen hundred and 39 ten, ten thousand eight hundred and five dollars.

STATEMENT OF FACTS.

The State of Maine holds in trust for the Passamaquoddy Tribe of Indians a large sum of money to which there is being added each year money derived from the sale of land and stumpage from Indian township. The only money the Indians have had from the above fund was for building of a Sisters' Home at Peter Dana's point and a church at Pleasant point.
