STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT to ratify the organization, acts and doings and extend
the powers of the Limerick Water and Electric Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The organization of the Limerick Water and
2 Electric Company, a corporation created by chapter one hun-
3 dred and fifty-nine of the private and special laws of one
4 thousand nine hundred and seven, duly organized and exist-
5 ing under the laws of the State of Maine, is hereby ratified,
6 confirmed and declared to be legal and valid.

Sect. 2. The right, power and authority of the said cor-
2 poration to erect and maintain under the powers previously

3 granted the dam constructed by it across the Little Ossipee
4 river at the point known as "The Ledges" in the towns of
5 Limerick and Waterboro is hereby ratified and confirmed.

The said corporation shall provide, erect and maintain a
7 suitable sluiceway in the said dam for the passage of logs
8 and lumber.

Sect. 3. The said corporation is hereby authorized and
2 empowered to exercise and enjoy all of its corporate rights,
3 powers and privileges in the towns of Limington and Hollis
4 in the county of York and Standish in the county of Cum-
5 berland, in addition to the towns named in its said act of
6 incorporation; to furnish, supply, sell and lease to, and to
7 purchase, procure and lease electricity or electric power
8 from, any and all light, power and transportation companies
9 doing business in the said towns of Limerick, Newfield,
10 Waterboro, Limington, Hollis and Standish, or in any towns
11 adjacent to any of said towns.

Sect. 4. The said corporation shall have authority to ac-
2 quire by purchase or lease any existing dam or dams on said
3 Little Ossipee river, or its tributaries, including Brown
4 brook, so called, and on the Saco river, and any real estate
5 in said towns which it may deem necessary, expedient or
6 convenient for its purposes as set out in its charter and for
7 any and all other lawful purposes, and to hold, enjoy, oper-
8 ate, lease, sell and convey the same.
