*To the Honorable Senate and House of Representatives of  
Maine in Legislature assembled:*

The undersigned, assessors of taxes for the town of Starks in the county of Somerset, respectfully represent that in 1907 a portion of said town of Starks was set off from said town on to the town of Norridgewock in said county by Chapter 132 of the Private Acts of this Legislature for that year; that in said act no provision was made for the payment by the town of Norridgewock of the State and county taxes assessed on that portion of said town of Starks set off on to said town of Norridgewock for the years 1907 and 1908; that request was made by the town of Starks to the town of Norridgewock to pay the State and county taxes assessed on that portion of the town thus set off for the year 1907, which the said town of Norridgewock refused to do; that said taxes have been paid by the town of Starks for the year 1907.

Now, therefore, the undersigned, assessors of said town of Starks, respectfully request that said town be reimbursed for the county and State taxes thus paid by it on that portion of said town for the year 1907 set off on to the town of Norridgewock, said county tax amounting to the sum of fifty-four dol-

lars and forty-four cents (\$54.44), and said State tax to the sum of one hundred twenty-one dollars and twenty-six cents (\$121.26), in all to the sum of one hundred seventy-five dollars and seventy cents (\$175.70).

*Resolved,* That the sum of one hundred seventy-five dollars and seventy cents be, and is hereby appropriated to the town of Starks to reimburse said town for a State tax of one hundred twenty-one dollars and twenty-six cents and a county tax of fifty-four dollars and forty-four cents paid by said town of Starks on that portion of said town set off from the town of Starks on to the town of Norridge-wock in 1907.
