RESOLVE in favor of Eugene A. Holmes, County Attorney
of Aroostook County.

Resolved, That there be and hereby is appropriated the
2 sum of ninety-six dollars and twenty-seven cents in favor
3 of Eugene A. Holmes, county attorney for Aroostook coun-
4 ty, to reimburse him for personal funds expended in obtain-
5 ing evidence resulting in conviction in the murder case of
6 State vs. John Roberts.

STATEMENT OF FACTS.

The county attorney of Aroostook county, Eugene A. Holmes, in the murder case of State vs. John Roberts, expended the amount as shown in the annexed bill of items, in obtaining evidence which finally resulted in the conviction of John Roberts for the murder of one Dickinson. The county commissioners refuse to allow this bill, and, as the expenses were not incurred in actual trial, the court cannot approve the same.
