IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT to incorporate the Maple Grove Electric Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Clarence A. Powers, James R. Thurlough,
2 Charles M. Waldron, Isaac Conant and Albert T. Hoyt,
3 their associates, successors and assigns are hereby made a
4 body corporate by the name of the Maple Grove Electric
5 Company.

Sect. 2. The said corporation is hereby authorized to
2 transmit, supply, sell and distribute electricity, for light,
3 heat and power, in and through all that portion of the Town
4 of Fort Fairfield which was formerly Township Letter D,
5 Range One, according to survey and plan of said Letter D
6 Township made by Thomas Sawyer, except that portion of

7 said Township particularly described in chapter 166, Private
8 and Special Laws of 1887, entitled An Act creating the Fort
9 Fairfield Village Corporation.

Sect. 3. All locations upon streets, roads or ways in said
2 town, necessary for the purposes of this act, are hereby
3 granted and the municipal officers of said Town of Fort
4 Fairfield shall designate the streets, roads and ways, so to be
5 occupied, the places where the poles shall be set and may
6 establish reasonable restrictions as to the kind of poles, their
7 construction and maintenance, the height of wires and the
8 use of guard wires.

Sect. 4. Except as otherwise provided herein, sections
2 three, four, five, six, seven, eight, ten, eighteen, nineteen,
3 twenty, twenty-one, twenty-two, twenty-three and twenty-
4 four of chapter fifty-five of the Revised Statutes are hereby
5 made applicable to the corporation hereby created.

Sect. 5. The capital stock of said corporation shall not ex-
2 ceed twenty-five thousand dollars, to be fixed from time to
3 time by the stockholders thereof.

Sect. 6. The said corporation, for the purposes of this act,
2 is hereby authorized to issue bonds and to secure the same by
3 mortgages of its property and franchises.

Sect. 7. The said corporation is authorized to purchase
2 electric current, for the purposes of this act, from an in-
3 dividual, corporation or firm.

Sect. 8. Subject to all the limitations and provisions of
2 this act, the said Maple Grove Electric Company is hereby

3 authorized to sell or lease its capital stock, property and
4 franchises to the Maine and New Brunswick Electrical
5 Power Company, Limited, its sucesors and assigns, upon
6 such terms as may be agreed upon, and upon such purchase
7 or lease, the said Maine and New Brunswick Electrical
8 Power Company, Limited, its sucesors and assigns, shall
9 have, hold, possess, exercise and enjoy, all the locations,
10 powers, privileges, rights, immunities, franchises, property
11 and assets, which at the time of such transfer shall then be
12 had, held, possessed or enjoyed by the Maple Grove Electric
13 Company and shall then be subject to all the duties, restric-
14 tions and liabilities to which the said Maple Grove Electric
15 Company shall then be subject. Such sale or lease may be
16 made in like manner and under like restrictions to the Fort
17 Fairfield Light and Power Company, its successors and as-
18 signs.
