IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE

AN ACT to incorporate the trustees of an academy under the
name of the Nasson Institute.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Harmon G. Allen, George A. Goodwin and
2 Samuel D. Hanson with their associates and successors, are
3 hereby created a corporation by the name and style of the
4 trustees of an academy under the name of the Nasson Insti-
5 tute, for the purpose of establishing and maintaining an in-
6 stitution of learning in the village of Springvale in the town
7 of Sanford, in the county of York, and by that name may
8 sue and be sued; and have a common seal; may make any by-
9 laws for the management of their affairs, not repugnant to

10 the laws of this State, and may take and hold by gift, grant,
11 devise, bequest or otherwise, any lands, tenements, or other
12 estate, real or personal and may give, grant or lease the
13 same; and may choose all officers necessary for the profitable
14 management of their concerns and for the usefulness and ad-
15 vancement of said institute, provided, the sole purpose of said
16 corporation shall be to inculcate and diffuse useful knowl-
17 edge.

Sect. 2. The above named trustees, with such associates
2 and successors as they may from time to time elect shall con-
3 stitute the trustees of the said Nasson Institute. They may
4 determine the number of trustees, the tenure of office and
5 what number shall constitute a quorum of the board of said
6 trustees, and how many thereof shall be residents of San-
7 ford.

Sect. 3. All deeds or conveyance of real estate, under the
2 direction of the trustees of said corporation, and sealed with
3 their seals, signed and acknowledged by their treasurer, shall
4 be valid.

Sect. 4. Said corporation is hereby authorized to receive
2 the any and all property of the estate of George Nasson late
3 of Sanford, deceased, to be held, managed and disposed of
4 for the purposes of said corporation, providing the transfer
5 of said property as aforesaid be sanctioned and allowed by
6 the judge of probate for the county of York and to be held

7 under such restrictions and upon such conditions as the court
8 shall authorize and direct.

Sect. 5. Said corporation shall have all other powers,
2 financial assistance and privileges as are given to academies
3 and to similar corporations.

Sect. 6. Any one of the persons named in section one, may
2 call the first meeting of the trustees by notice served upon
3 the others.
