STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to amend sections ninety-four, ninety-six and ninetyseven of chapter fifteen of the Revised Statutes of nineteen hundred and three providing for the schooling of children in unorganized townships.

Be it enacted by the People of the State of Maine, as follows:

Section I. Section ninety-four of chapter fifteen of the Re-2 vised Statutes is hereby amended by striking out the word 3 "twenty" in line fourteen of said section and inserting in 4 place thereof the word 'twenty-six' and by striking out all 5 words after the word "township" in line seventeen of said 6 section and inserting in place thereof the words 'shall have 7 been assessed by the duly appointed agent therefor the sum 8 of forty cents for each of said inhabitants resident therein on 9 the first day of April, and said agent shall have made return

10 of such assessment to the State superintendent of public 11 schools,' so that said section shall read as follows:

'Section 94. Whenever in any unorganized township in 13 the State there shall be two or more children between the 14 ages of five and twenty-one years, the State superintendent 15 of public schools shall cause an enumeration of said children 16 to be made and returned to him, and shall provide for the 17 schooling of said children, either by establishing a school in 18 the township, or by sending the children to schools in ad-10 joining towns or plantations, or both, as shall by him be 20 deemed expedient. In case any of said children are, by the 21 State superintendent, sent to schools in adjoining towns or 22 plantations, said children so sent shall have the same rights 23 in such schools as children resident in said town or planta-24 tion. Provided, however, that in case the interest on the 25 reserved fund in any unorganized township together with the 26 amount arising from the per capita tax called for in this sec-27 tion, is not sufficient to provide schooling for the children of 28 said township for at least twenty-six weeks in a year the re-20 mainder of the expense shall be paid from the fund appro-30 priated by section ninety-seven. Provided, further, that no 31 money shall be expended under this section for the benefit of 32 any township until the inhabitants of said township shall 33 have been assessed by the duly appointed agent therefor the 34 sum of forty cents for each of said inhabitants resident 35 therein on the first day of April, and said agent shall have

36 made return of such assessment to the State superintendent37 of public schools.

Sect. 2. Section ninety-six is hereby amended in line four-2 teen thereof by substituting for the word "fifteenth" the 3 word 'seventeenth' so that said section as amended shall read 4 as follows:

'Section 96. The State superintendent of public schools 6 may appoint agents for the several townships in which 7 schools shall be established under section ninety-four, who 8 shall, under the direction of the State superintendent, enu-9 merate the pupils, assess and collect the per capita tax, em-10 ploy the teacher and attend to all necessary details in con-II nection with said schools; for which work they shall be paid 12 a sum not exceeding two dollars a day, when actually em-13 ployed in this duty, and actual necessary traveling expenses. 14 Said agents in the collection of the per capita tax aforesaid, 15 shall have the same powers and may use the same methods 16 as collectors of taxes in towns are authorized to exercise and 17 use for the collecting of personal and poll taxes committed 18 to them; said agents may act as truant officers in their sev-19 eral townships, and may in their discretion compel the regu-20 lar daily attendance at school of every child in their town-21 ships between the seventh and seventeenth anniversaries of 22 his birth by arresting and taking to school any child 23 when absent therefrom, and any parent or guardian of any 24 such child or children, wilfully refusing to allow said chil-

25 dren under his control to attend school, or opposing said 26 agent in arresting and taking said children to school, may be 27 prosecuted by said agent in the name of the State before the 28 nearest trial justice, and if found guilty shall forfeit a sum 29 not exceeding twenty dollars for the use of the schools in the 30 township wherein said children are resident, or shall be im-31 prisoned for not exceeding thirty days. The State superin-32 tendant may supply school books for the schools established 33 under said section under such conditions as to the purchase 34 and care thereof as he may deem proper.

Sect. 3. Section ninety-seven as amended by chapter forty-2 five of the Public Laws of nineteen hundred and five is 3 hereby further amended by striking out the word "seven" in 4 line two as amended and substituting in place thereof the 5 word 'fifteen' so that said section when amended shall read 6 as follows:

'Section 97. For the purpose of carrying out the provisions
8 of the three preceding sections, there is hereby appropriated
9 the sum of fifteen thousand dollars annually, which sum shall
10 be deducted and set aside therefor by the treasurer of State
11 from the annual school funds of the State.
