IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND NINE.

AN ACT to amend section sixty-one of chapter forty-one of  
the Revised Statutes of nineteen hundred and three, relating  
to Sea and Shore Fisheries.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Section sixty-one of chapter forty-one of the  
2 Revised Statutes of nineteen hundred and three is hereby  
3 amended by striking out all after the word "advisable" in  
4 the seventh line and inserting in place thereof the words  
5 'All fines, penalties and collections under this chapter, ex-  
6 cept when otherwise expressly provided, shall forthwith be  
7 paid to the commissioner of sea and shore fisheries and by  
8 him be paid to the treasurer of state to be added to and

9 made a part of the appropriation for sea and shore fish-  
10 eries, so that said section as amended shall read as follows:

‘Sect. 61. All fines and penalties under this chapter may  
12 be recovered by complaint, indictment or action of debt  
13 made or brought in the county where the offense was com-  
14 mitted. The action of debt shall be brought in the name  
15 of the commissioner of sea and shore fisheries, and all  
16 offenses under, or violations of, the provisions of this stat-  
17 ute, may be settled by the commissioner of sea and shore  
18 fisheries, upon such terms and conditions as he deems advis-  
19 able. All fines, penalties and collections under this chap-  
20 ter, except when otherwise expressly provided, shall forth-  
21 with be paid to the commissioner of sea and shore fisheries  
22 and by him be paid to the treasurer of state to be added to  
23 and made a part of the appropriation for sea and shore  
24 fisheries. And the commissioner shall report to the State  
25 treasurer the amount of each fine, penalty and collection  
26 itemized and the name of the party paying same, which  
27 shall be kept on record in the treasurer’s office.
