## STATE OF MAINE.

RESOLVE in favor of the town of Abbot for one hundred and forty dollars to be paid to the town of Abbot on account of State road constructed in the year nineteen hundred and seven.

---

*Resolved,* That the sum of one hundred and forty dollars  
2 be and hereby is appropriated to reimburse the town of  
3 Abbot on account of State road construction in the year  
4 nineteen hundred and seven.

Abbot, Maine, February 1st, 1909.

Mr. Charles J. Chase, Augusta, Maine.

Dear Sir:—In the year 1907 we raised the sum of two hundred dollars (\$200.00) for State road. The State was to furnish the same amount under the old law, making a total of four hundred dollars (\$400). We expended two hundred eighty dollars (\$280) and it was such wet weather that we could not complete the road in time for the Commissioners to approve of the work done. In the year 1908 the State road law was changed, the Commissioners having nothing to do with it, so that we have not received anything for the amount expended in 1907. We now ask that we be reimbursed for the sum of one hundred and forty dollars (\$140), the same being one-half the amount expended.

In the year 1908 we expended our State road money on the road worked in 1907 and road adjoining, the work being approved by H. S. Towne for Paul D. Sargent, State Road Commissioner.

Will you please, as representative from this district, lay the enclosed bill before the proper committee and use your influence to have the same approved?

We the undersigned Selectmen of the town of Abbot and State of Maine respectfully request that the town of Abbot be reimbursed for the sum of one hundred forty dollars (\$140.00), the same being one-half the amount expended in the year 1907, for State road. Said road was not completed until the year 1908 on account of wet weather, so that we have not received the amount we are entitled to from the State.
