STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to incorporate the Woodland Light and Water Company.

Be it enacted by the People of the State of Maine, as follows:

Section I. George A. Curran, Arthur L. Hobson and 2 James M. Lavin, their associates, successors and assigns, are 3 hereby made a body corporate by the name of Woodland 4 Light and Water Company, with all the powers, rights and 5 privileges and subject to all the duties and obligations con-6 ferred and imposed upon corporations by the laws of this 7 State.

Sect. 2. Said Company is hereby authorized to generate, 2 make, buy, sell, distribute and supply electricity and electric 3 power for lighting, heating, manufacturing and mechanical 4 purposes and to take, use, sell and distribute water from the 5 St. Croix river for municipal and domestic purposes with-6 in the town of Baileyville in the County of Washington, with 7 all the rights, privileges and powers and subject to all the 8 restrictions and liabilities by law incident to such corpora-9 tions.

Sect. 3. Said corporation is hereby empowered to locate, 2 construct and maintain reservoirs, standpipes, gates, hydrants 3 and pipes to conduct and distribute water, to set poles, ex-4 tend wires, construct conduits and necessary fixtures upon, 5 in, through, along, across, over and under the roads, ways 6 and streets in said town of Baileyville, under such reasonable 7 restrictions and conditions as the selectmen of said town 8 may impose and shall, except in case of accident, furnish 9 a continuous and sufficient supply of water for above uses 10 and all buildings requiring the same within a reasonable 11 distance and at reasonable rates.

Sect. 4. Said corporation is hereby authorized to make 2 contracts with the said town of Baileyville, and with in-3 dividuals and corporations therein, to supply water, light, 4 heat and electric power for municipal, domestic and business 5 purposes.

Sect. 5. The capital stock of the corporation shall not 2 exceed five thousand dollars divided into shares of one hun-

3 dred dollars each. Said company is hereby authorized to 4 purchase or lease from St. Croix Paper Company any prop-5 erty or rights require for the purposes of this act and may 6 pay for the same in stock of this company, which said Paper 7 Company is hereby authorized to acquire and hold.

Sect. 6. The first meeting of the corporators may be held 2 by consent at any time prior to the first day of July next.

Sect. 7. This act shall become null and void in one year 2 from the time when the same takes effect, unless the corpora-3 tion shall be in actual operation.
