STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to amend Section one of Chapter one hundred sixtysix of the Private and Special Laws of eighteen hundred eighty-seven, entitled "An Act creating the Fort Fairfield Village Corporation," as amended by Chapter three hundred three of the Private and Special Laws of nineteen hundred five, and as amended by Chapter one hundred sixteen and by Chapter two hundred ten of the Private and Special Laws of nineteen hundred seven.

Be it enacted by the People of the State of Maine, as follows:

Section one of Chapter one hundred sixty-six of the Pri2 vate and Special Laws of eighteen hundred eighty-seven as
3 amended by Chapter three hundred three of the Private and
4 Special Laws of nineteen hundred five, and as amended by

5 Chapter one hundred sixteen and by Chapter two hundred 6 ten of the Private and Special Laws of nineteen hundred 7 seven, is hereby amended by inserting in line two thereof 8 after the word "ten" the words "except so much of said lot 9 ten as lies west of a line extending northerly from the south-10 east corner of Gordon E. Boyer's house lot, parallel with the 11 west line of said lot ten, to the north line thereof," so that 12 said section as amended shall read as follows:

'Section 1. The following described territory: Lots 14 numbered two, three, except so much of said lot three as is 15 now embraced in the farm of W. Holman Fisher, eight, 16 nine, ten, except so much of said lot ten as lies west of a line 17 extending northerly from the southeast corner of Gordon E. 18 Boyer's house lot, parallel with the west line of said lot ten, 19 to the north line thereof, eleven, twelve, thirteen, fourteen, 20 fifteen and all of lot seventy-nine, except that portion thereof 21 on the northwesterly side of the Presque Isle Road, so-22 called, and that portion thereof now owned or occupied by 23 George H. Churchill, in the town of Fort Fairfield, accord-24 ing to Sawyer's survey of township Letter D, in the first 25 range, together with the inhabitants therein, be and the 26 same are hereby created a body politic and corporate by the 27 name of the Fort Fairfield Village Corporation.'

STATEMENT OF FACTS.

Statement of facts accompanying bill, "An Act to amend Section one of Chapter one hundred sixty-six of the Private and Special Laws of eighteen hundred eighty-seven, entitled, 'An Act creating the Fort Fairfield Village Corporation' as amended by Chapter three hundred three of the Private and Special Laws of nineteen hundred five, and as amended by Chapter one hundred sixteen and by Chapter two hundred ten of the Private and Special Laws of nineteen hundred seven."

That portion of lot numbered ten in the town of Fort Fairfield, which, under the accompanying bill, would be excepted from the Fort Fairfield Village Corporation, is located so far away from the system of water works in use in Fort Fairfield Village, that it receives no benefit whatever therefrom, nor from any of the other purposes for which said Fort Fairfield Village Corporation was formed. The owners of the property on this excepted portion feel, therefore, that they should be excluded from the Fort Fairfield Village Corporation, and thereby relieved from paying taxes therein, from which they can receive no benefit whatever on account of their location.
