STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT to authorize the Van Buren Water District to issue
bonds.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The Van Buren Water District, in the town
2 of Van Buren, in the county of Aroostook and State of
3 Maine, is hereby authorized to issue its bonds to an amount
4 not exceeding thirty thousand dollars in all, in addition to
5 the amount of the bonds of the said Water District already
6 issued and outstanding, to extend its system and to make
7 such additions and improvements, as in the judgment of
8 the trustees for the time being shall be deemed advisable.

Sect. 2. The whole amount or any portion thereof, may
2 be authorized by a vote of a majority of the legal voters
3 present and voting at any legal meeting called therefor; by

4 virtue of a warrant signed by the trustees of said Water
5 District for the time being, containing proper articles, stat-
6 ing the purpose or purposes of said meeting, directed to
7 any constable of the town of Van Buren, residing within
8 the limits of the Water District. Until the entire amount
9 hereby authorized shall have been so voted and bonds issued
10 in pursuance thereof, another meeting or several meetings
11 may be held, called in the manner herein provided, and an
12 additional sum or additional sums may be voted, until the
13 whole amount contemplated by this act has been voted, and
14 bonds issued in pursuance thereof.

Sect. 3. Except as hereinbefore provided, any and all
2 meetings called for the purpose or purposes contemplated
3 by this act, shall be called and held in accordance with the
4 provisions governing the calling and holding of town meet-
5 ings. The clerk of the Water District shall be the clerk
6 of the meeting or meetings called in pursuance of this act,
7 and all records made relative thereto shall be duly made and
8 attested by him.

Sect. 4. At any such meeting, the legal voters of said
2 Water District present and voting, may authorize its trus-
3 tees for the time being to issue bonds in such denomina-
4 tions, signed by them and countersigned by their treasurer,
5 and payable at such time or times, and bearing such rate
6 of interest as such trustees shall deem most advantageous
7 for the said Water District.
