IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT to incorporate the North Jay Electric Company.

Be it enacted by the People of the State of Maine, as follows :

Sect. 1. Frank A. Emery, H. L. Shepherd, George E.
2 Monroe and C. N. Blanchard, there associates, successors,
3 and assigns, are hereby made a body corporate by the name
4 of the North Jay Electric Company.

Sect. 2. Except as otherwise herein provided, the said
2 corporation is hereby authorized to transmit, supply, sell and
3 distribute electricity for light, heat and power in and
4 through Wilton and Jay, but no electricity shall be sold for
5 any purpose in Wilton without the consent of all persons,
6 firms or corporations supplying, selling and distributing, or

7 authorized to supply, sell and distribute electricity or gas
8 in said Wilton, and no electricity shall be sold by said com-
9 pany in that part of Jay known as Jay Bridge, and Chis-
10 holm. The jurisdiction of the company in Jay shall extend
11 on the south to the railroad crossing of the Maine Central
12 railroad track at the foot of the Jay Hill, so-called, in the
13 town of Jay.

Sect. 3. All locations upon streets, roads, or ways in said
2 towns and plantations necessary for the purposes of this
3 act, are hereby granted, and the municipal officers of the
4 towns of Wilton and Jay shall designate the streets, roads
5 or ways so to be occupied, the places where the poles shall
6 be set, and may establish reasonable restrictions as to the
7 kind of poles, their construction and maintenance, the height
8 of wires and the use of guard wires.

Sect. 4. Except as otherwise provided herein, sections
2 three, four, five, six, seven, eight, ten, eighteen, nineteen,
3 twenty, twenty-one, twenty-two, twenty-three, twenty-four
4 of chapter fifty-five of the revised statutes are hereby made
5 applicable to the corporation hereby created.

Sect. 5. The capital stock of said corporation shall not
2 exceed fifty thousand dollars, to be fixed from time to time
3 by the stockholders thereof.

Sect. 6. The said corporation, for the purposes of this
2 act, is hereby authorized to issue bonds from time to time,

3 and to secure the same by appropriate mortgages of its
4 property and franchises.

Sect. 7. The said corporation is hereby authorized to
2 purchase or lease the capital stock, property and franchises
3 of the Wilton Electric Light, Gas and Power Company,
4 upon such terms as may be agreed upon, and the said Wil-
5 ton Electric Light, Gas and Power Company is authorized
6 to make such sale or lease.
