STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to set off a portion of the town of Berwick and annex the same to the town of South Berwick.

Be it enacted by the People of the State of Maine, as follows:

- Section 1. The following tract of land, together with the
- 2 inhabitants thereof, is hereby set off from the town of Ber-
- 3 wick and annexed to the town of South Berwick; beginning
- 4 at a point on the Western Division of the Boston and Maine
 - 5 Railroad near the property of Joseph St. Lawrence where
 - 6 the line dividing the towns of South Berwick and Berwick
 - 7 intersects said railroad; thence easterly along the line divid-
 - 8 ing said towns as said line is now layed out and located to
 - o the North Berwick town line; thence northwesterly by the

10 line dividing the towns of Berwick and North Berwick as
11 now layed out to the point where said town line between
12 North Berwick and Berwick intersects the Western Division
13 of the Boston and Maine Railroad; thence southerly by said
14 Boston and Maine Railroad to a point one hundred feet
15 northerly from the northern end of the Boston and Maine
16 Railroad freight house at South Berwick Station as it now
17 stands; thence westerly at right angles to the line of the
18 Boston and Maine Railroad at this point to the northwester19 ly side line of the land of the Boston and Maine Railroad;
20 thence by said side line of the Boston and Maine Railroad
21 property to a point where a line from the point of beginning
22 perpendicular to the line of the Boston and Maine Railroad
23 at that point intersects said side line; thence to point of be24 ginning.

- Sect. 2. All pauper settlements, or hereafter arising by 2 virtue of residence, upon the territory hereby set off, of the 3 pauper or some under whom a settlement is derived, shall be 4 held to be in South Berwick.
- Sect. 3. All officers of said Berwick shall have the same 2 powers as to all taxes now assessed and unpaid, upon polls 3 resident upon, or estate located within said territory as they 4 have by law as to other polls or estates within said Berwick. Sect. 4. This act shall not affect any process now pending 2 in court.
 - Sect. 5. This act shall take effect when approved.
