STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND NINE.

AN ACT to authorize the Rangeley Lakes Steamboat Company
to maintain wharves in the Rangeley Lake.

Be it enacted by the People of the State of Maine, as follows :

Section 1. The Rangeley Lakes Steamboat Company, a
2 corporation duly established and existing under the laws of
3 the State, its successors and assigns, are hereby authorized
4 and empowered to maintain and control a wharf; erected by
5 them, or by their predecessors and by them conveyed to said
6 Steamboat Company; commencing at the southerly end of
7 Lake Street, in Rangeley Village in the town of Rangeley
8 in the county of Franklin, and extending into the water
9 of Rangeley Lake at a sufficient length and width to allow
10 the landing of boats and steamers. Also to maintain and

11 control a wharf; erected by them, or by their predecessors
12 and by them conveyed to said Steamboat Company; near
13 the foot of Rangeley in the town of Rangeley aforesaid,
14 commencing at the end of the road leading from Haines
15 Landing to Rangeley Outlet wharf, and extending into the
16 water of Rangeley Lake at a sufficient length and width to
17 allow the landing of boats and steamers.

Sect. 2. The location, erection, maintenance and control
2 of any wharves located and described as aforesaid already
3 constructed, before the approval of this act, by the said
4 Rangeley Lakes Steamboat Company or its predecessors are
5 hereby legalized, ratified and confirmed and the said Range-
6 ley Lakes Steamboat Company, its successors and assigns,
7 are hereby authorized to maintain and control such wharves.

Sect. 3. This act gives said Steamboat Company no au-
2 thority to exclude parties not doing business for hire from
3 the use of said wharves and said Steamboat Company shall
4 designate such reasonable portion of said wharves, as will
5 not interfere with their own use of them, for the use of
6 private boats and individuals.
