### MAJORITY REPORT.

## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to provide for the Attorney General or Assistant Attorney General to take charge of liquor prosecutions, upon failure or refusal of the county attorney to perform his duty, and for the prosecution of such county attorney.

## Be it enacted by the People of the State of Maine, as follows:

Section 1. Upon application to the justice presiding at any

- 2 term of the Supreme Judicial Court having cognizance of
- 3 criminal cases, the Attorney General or Assistant Attorney
- 4 General may take charge of all prosecutions relating to the
- 5 law against the manufacture and sale of intoxicating liquors,
- 6 including prosecutions for liquor nuisances under Chapter
- 7 22, Section 1 of the Revised Statutes, and shall have full
- 8 charge and control thereof.

- Sect. 2. It shall be the duty of the Attorney General to 2 make such application upon direction of the Governor, or 3 whenever he shall be satisfied that the county attorney of 4 any county has wilfully failed or refused to perform the 5 duties enjoined upon him by Chapter 29 of the Revised 6 Statutes and acts amendatory thereof.
- Sect. 3. Whenever the Attorney General or Assistant 2 Attorney General shall take charge of the prosecutions 3 aforesaid in any county, it shall be his duty to present to the 4 grand jury the evidence of the failure or refusal of the 5 county attorney as aforesaid, and if an indictment shall be 6 found, to further prosecute the same to final judgment.
