STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to incorporate Phillips Electric Light and Power Com-

pany.

Be it enacted by the People of the State of Maine, as follows: Section 1. Herbert H. Berry, Newell P. Noble, Frank C.
Nelson and Elliott C. Dill, their associates, successors and
assigns, are hereby made a body corporate by the name of
Phillips Electric Light and Power Company.

Sect. 2. Said corporation is hereby authorized to make, 2 generate, transmit, supply, sell and distribute electricity for 3 light, heat and power, in and throughout the towns of Phil-4 lips and Avon, in the County of Franklin, to said towns, cor-5 porations, firms and individuals.

Sect. 3. All locations upon streets, roads or ways in said

2 towns necessary for the purposes of this act are hereby 3 granted, and the municipal officers of said towns shall desig-4 nate the streets, roads or ways so to be occupied, the loca-5 tion of the poles, and may establish reasonable restrictions 6 as to kind of poles, their construction and maintenance, the 7 height of wires and use of guard wires.

Sect. 4. Except as herein otherwise provided, sections 2 three, four, five, six, seven, eight, ten, eighteen, nineteen, 3 twenty, twenty-one, twenty-two, twenty-three and twenty-4 four of Chapter fifty-five of the Revised Statutes are hereby 5 made applicable to the corporation hereby created.

Sect. 5. Said corporation is authorized to locate, construct 2 and maintain a dam or dams on any brooks or streams lying 3 wholly or partly within said towns, provided that the flow-4 age of water thereby caused shall not interfere with any mill 5 or dam existing at such time as said corporation may erect 6 a dam or dams as aforesaid.

Sect. 6. The capital stock of said corporation shall not 2 exceed twenty-five thousand dollars, to be fixed from time to 3 time by the stockholders thereof.

Sect. 7. Said corporation for the purposes of this act is 2 hereby authorized to issue bonds from time to time and se-3 cure the same by appropriate mortgages of its property and 4 franchises.

Sect. 8. Said corporation is hereby authorized to acquire 2 by purchase, the plants, property, franchises, rights, priv-3 ileges and locations of other corporations, firms or individ4 uals engaged in any of the kinds of business hereinbefore 5 named, in said towns, and such corporations, firms or indi-6 viduals are hereby authorized to convey, transfer and assign 7 such plants, property, franchises, rights, privileges and loca-8 tions to said Phillips Electric Light and Power Company 9 which shall have, hold, enjoy and exercise the same for its 10 own uses and purposes as though originally granted to it.

Sect. 9. Said corporation is hereby authorized to contract 2 with any individual, firm or corporation for the purpose of 3 buying or selling power, as the needs of its business may re-4 quire or permit.

Sect. 10. The first meeting of said corporation may be 2 called by written notice thereof, signed by any incorporator 3 herein named, and served upon each incorporator by copy of 4 the same in hand, or mailed, postage paid, at least seven 5 days prior to the day named therein for such meeting.
