AN ACT relating to The Mount Desert Transit Company.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. The charter of The Mount Desert Transit  
2 Company, granted under the provisions of Chapter 53 of  
3 the Revised Statutes, together with all rights, powers and  
4 privileges possessed by said corporation by virtue of its  
5 charter and all rights, powers and privileges granted by  
6 this Act, are hereby extended in full force until the first  
7 day of August, 1913, at which date the corporate existence  
8 and powers of said corporation shall cease except as pro-  
9 vided by Section 77 and 78 of Chapter 47 of the Revised

10 Statutes, unless the same shall be continued by the per-  
11 formance before that date of the conditions specified by  
12 Section 10 of Chapter 53 of the Revised Statutes.

Sect. 2. Said corporation shall have and possess all rights,  
2 powers and privileges granted to railroad corporations,  
3 either expressly or by reference, under the provisions of  
4 said Chapter 53 and amendments thereof, and also all the  
5 rights, powers and privileges granted to it by Chapter 60  
6 of the Private and Special Laws of 1907, and in addition  
7 thereto shall have and possess the rights, powers and priv-  
8 ileges enumerated in the following sections.

Sect. 3. Said The Mount Desert Transit Company shall  
2 be and is hereby authorized and empowered to use steam  
3 as a motive power for its locomotives, engines, trains and  
4 cars, in connection with or in addition to the motive power  
5 specified in said Chapter 53.

Sect. 4. Said The Mount Desert Transit Company is  
2 hereby authorized and empowered to connect its railroad  
3 with the railroad of any other corporation which may now  
4 or hereafter own or operate a line of railroad wholly or  
5 partly in Hancock County, Maine, and any such other rail-  
6 road corporation is hereby authorized to connect its rail-  
7 road with the railroad of The Mount Desert Transit Com-  
8 pany upon any terms and conditions mutually agreed upon  
9 and not prohibited by the laws of the State of Maine; and  
10 The Mount Desert Transit Company is hereby authorized  
11 to sell or lease its property and franchises to any such con-

12 necting railroad corporation, or to any railroad corporation  
13 leasing or operating any connecting railroad; and any such  
14 railroad corporation is hereby authorized to acquire by  
15 purchase, lease or otherwise the property and franchises  
16 of said The Mount Desert Transit Company, and also to  
17 acquire, hold and possess the stocks, bonds and securities  
18 of said The Mount Desert Transit Company.
