HUNDRED AND ELEVEN.

AN ACT to set off a part of the town of Rangeley and incorporate it as Oquossoc Plantation.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. All that part of the town of Rangeley in the  
2 County of Franklin and State of Maine, bounded by com-  
3 mencing at a point on the westerly shore of Rangeley Lake  
4 at the point of intersection of the north line of Rangeley  
5 Plantation with said lake southerly of South Rangeley Sta-  
6 tion, so called; thence northerly along the westerly shore  
7 of said lake to the outlet thereof; thence along said outlet  
8 to Mooselukmaguntic Lake; thence southerly along the  
9 easterly shore of said Mooselukmaguntic Lake to the north

10 line of said Rangeley Plantation; thence easterly along the  
11 northerly line of said Rangeley Plantation to the point be-  
12 gun at, together with the inhabitants thereof, is hereby set off  
13 from said town of Rangeley and incorporated into a planta-  
14 tion by the name of Oquossoc Plantation. And said planta-  
15 tion is hereby invested with all the powers and privileges  
16 and subject to all the duties and obligations incident to other  
17 plantations of the State.

Sect. 2. The inhabitants aforesaid shall be holden to pay  
2 all taxes which have been legally assessed upon them in the  
3 town of Rangeley and the collector of taxes for said town  
4 of Rangeley is authorized and required to collect and pay  
5 over the same. All money in the treasury of said town of  
6 Rangeley and all unpaid taxes in said town shall be used  
7 for the purposes for which they were assessed.

Sect. 3. The existing liabilities of said town of Rangeley  
2 shall be borne by the town of Rangeley. All paupers now  
3 supported or aided by said town of Rangeley shall after di-  
4 vision be maintained and supported by the town or planta-  
5 tion in whose territory they resided when they became  
6 paupers. The care and current expenses of the bridge at  
7 Oquossoc, so called, heretofore belonging to the town of  
8 Rangeley shall be borne equally between said town of Range-  
9 ley and said Oquossoc Plantation.

Sect. 4. The town property within the territory above set  
2 off shall become the property of Oquossoc Plantation, and

3 all such property real or personal remaining in said town  
4 shall become the property of said town of Rangeley.

Sect. 5. Any justice of the peace in the county of Frank-  
2 lin may issue his warrant to any legal voter in Oquossoc  
3 Plantation directing him to notify the inhabitants thereof  
4 at a time and place specified in said warrant, for the choice  
5 of plantation officers and to transact such business as planta-  
6 tions are authorized to do.

Sect. 6. This act shall take effect when approved.
