### STATE OF MAINE

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to incorporate the Bangor Chamber of Commerce and to unite same with the Bangor Board of Trade.

Be it enacted by the People of the State of Maine, as follows: Section 1. Arthur Chapin, Charles F. Bragg, Charles M.
2 Stewart, Frederick W. Adams, Arthur J. Waterman, Eugene
3 T. Savage, John G. Dunning, Frederick H. Parkhurst, Wil4 liam Conners, Langdon Freeze, James F. Singleton, John M.
5 Oak, Patrick H. Dunn and other members of a voluntary
6 association, now existing in the city of Bangor, under the
7 name of the Bangor Chamber of Commerce, are hereby con8 stituted a body politic and corporate by the name of the
9 Bangor Chamber of Commerce.

#### HOUSE-No. 88.

Sect. 2. The said Bangor Chamber of Commerce and the 2 Bangor Board of Trade, a corporation duly established under 3 the laws of this State, are hereby authorized to unite and 4 form one corporation under the name of the Bangor Cham-5 ber of Commerce.

Sect. 3. The objects of the new corporation shall be to 2 advance the industry, commerce and public interests of the 3 city of Bangor and vicinity.

Sect. 4. Said new corporation shall have all the rights, 2 powers, franchises and privileges now held by, and be sub-3 ject to all the liabilities, restrictions and duties now imposed 4 upon said Bangor Board of Trade.

Said Bangor Board of Trade is hereby authorized to assign, 6 transfer and convey to said new corporation all its rights, 7 privileges, interests, estates and properties, and said new cor-8 poration is authorized to receive and hold the same and shall 9 thereupon become liable, for all the debts and liabilities and 10 obligations of said Bangor Board of Trade.

Sect. 5. The new said corporation shall have power to 2 establish suitable by-laws to carry out all powers herein 3 granted, including provisions as to the admission, suspension 4 and expulsion of members, and delegation of powers to offi-5 cers, committees and directors.

Sect. 6. Until by-laws have been adopted by the new cor-2 poration, the by-laws of the said voluntary association, so 3 far as they are applicable and not inconsistent with this act, 4 shall be in force as to the new corporation.

Sect. 7. The said Bangor Chamber of Commerce author-2 ized hereinunder is hereby authorized to hold real and per-3 sonal estate to an amount not exceeding one hundred thou-4 sand dollars, with authority to sell, purchase, mortgage, lease 5 or rent the same or any part thereof.

Sect. 8. The officers of the new corporation shall consist 2 of a president, one or more vice presidents, a board of di-3 rectors and such other officers as may be determined by the 4 by-laws. All officers shall hold their offices for the length 5 of time fixed by the by-laws, and shall have and exercise the 6 powers prescribed in said by-laws.

The new corporation shall have power to expend the moneys 8 of the corporation for any and all purposes within the scope 9 of its charter and by-laws; and it may also receive, in trust 10 or otherwise, moneys or other property, real or personal, and 11 invest and expend the same for any of the objects of the 12 corporation as contained in the charter or by-laws.
