STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ELEVEN.

AN ACT to amend the Charter of the Ossipee Valley Power
Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section twelve of Chapter two hundred and
2 fifty-eight of the Private and Special Laws of nineteen
3 hundred and seven is hereby amended by adding after the
4 words "or elsewhere" in the sixth line of said Section, the
5 following, 'also to lease, purchase or otherwise acquire the
6 property, assets and franchises of the Sanford Water Com-
7 pany, or any other company now or hereafter engaged in
8 a similar business,' so that said section as amended shall read
9 as follows:

'Sect. 12. The said company is hereby authorized to

11 acquire by lease, purchase or otherwise, electricity and elec-
12 tric power, also the power plant, pole line, property and
13 assets, rights, privileges and franchises, or any part there-
14 of, of any corporation now or hereafter engaged in similar
15 business on said river and tributaries thereof, or elsewhere;
16 also to lease, purchase or otherwise acquire the property,
17 assets and franchises of the Sanford Water Company, or
18 any other company now or hereafter engaged in a similar
19 business, and to pay therefor wholly or partly in the stocks
20 and bonds of said Ossipee Valley Power Company, and
21 said corporations are hereby respectively authorized to
22 lease or sell electricity or electric power, also their respec-
23 tive power plants, pole lines, property and assets, rights,
24 privileges and franchises, or any part thereof, to said Os-
25 sipee Valley Power Company, and are hereby respectively
26 authorized to take, hold, sell, assign, transfer, mortgage,
27 pledge and otherwise dispose of shares of the capital stock
28 or bonds, securities or evidences of indebtedness of said
29 Ossipee Valley Power Company, with all the rights, pow-
30 ers and privileges of ownership therein conferred upon
31 corporations under Chapter forty-seven of the Revised Stat-
32 utes and amendments thereof and additions thereto. And
33 whenever, or as often as said Ossipee Valley Power Com-
34 pany has acquired by lease, purchase or otherwise, the
35 aforesaid power plant, pole lines, property and assets, rights,
36 privileges and franchises, or any part thereof, of any or all
37 of said corporations, said Ossipee Valley Power Company

38 shall thereupon succeed to and have, and is hereby author-
39 ized to exercise such of the rights, privileges and franchises
40 of any or all of said corporations acquired as aforesaid by
41 said Ossipee Valley Power Company.
