RESOLVE, in favor of Sullivan Newton.

Resolved: That there be and hereby is appropriated the
2 sum of thirty-two dollars and eighty-five cents to be paid
3 to Sullivan Newton of Jackman, for expense of fighting
4 forest fire in Jackman plantation in the fall of 1908.

STATEMENT OF FACTS.

This claim has not been paid for the reason that it was not before the legislature of 1909 to go along with the general deficiency bill for forest fires in the fall of 1908.

The accompanying Fire Warden's report is sworn to by Mr. Newton.

STATE OF MAINE.

Warden's Report of Forest Fire.

To the Forest Commissioner, Augusta.

A forest fire occurred in the north western part of Jackman, in the county of Somerset at hours and minutes of the clock in thenoon, on the 9th day of September, 1908.

The area burned consisted of unknown acres, on which the growth was of birch, spruce, fir and cedar, and I estimate the amount of damage by such fire at unknown dollars.

The fire had its origin in the north to east part of the township, the cause of same being by railroad fire of the C. P. R. R. Co., and was completely extinguished in the last part of October, 1908, after it started: the weather at the time was dry, wind westerly and southerly. The fire was extinguished in the following manner:
.and at a total expense of \$32.85.

performing labor the number of hours set against their respective name and post-office address:
