STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ELEVEN.

AN ACT to revive and amend chapter one hundred and fifty-four of the Private and Special Laws of eighteen hundred and ninety-five as amended by chapter one hundred and fifty-seven of the Private and Special Laws of nineteen hundred and seven, relating to the charter of the Wiscasset Water Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Chapter one hundred and fifty-four of the Private and Special Laws of eighteen hundred and ninety-five is hereby revived, and amended by adding after section ten of said chapter the two following sections: 'Sect. 11. The town of Wiscasset is hereby authorized and empowered to purchase and own stock of the Wiscasset Water Company to an amount not exceeding twelve thousand dollars at the

8 market value of said stock at the time when said purchase
9 may be made, and the person or persons and the Wiscasset
10 Water Company from whom the said stock may be purchased
11 are hereby authorized to transfer the same to said town, and
12 the municipal officers of said town shall appoint some person
13 to vote the stock so purchased as they may direct in all meet-
14 ings of said Wiscasset Water Company. Sect. 12. For the
15 purpose of raising money to carry out the provisions of sec-
16 tion eleven of this act the town of Wiscasset is hereby au-
17 thorized to issue its bonds with interest coupons, in behalf
18 of said town, signed by the municipal officers of said town
19 and the treasurer of said town in an amount not exceeding
20 twelve thousand dollars.'

Sect. 2. Section nine of chapter one hundred and fifty-
2 four of the Private and Special Laws of eighteen hundred
3 and ninety-five as amended by chapter one hundred and fifty-
4 seven of the Private and Special Laws of nineteen hundred
5 and seven is hereby amended as follows: The word "four-
6 teen" in said section as amended is stricken out and the word
7 'eighteen' inserted, so as that the section shall read as fol-
8 lows:

'Sect. 9. This act shall become null and void in eighteen
10 years from the approval thereof unless the corporation shall
11 have organized and commenced actual construction of its
12 works under this charter.'

Sect. 3. Said chapter one hundred and fifty-four of the
2 Private and Special Laws of eighteen hundred and ninety-

3 five is hereby revised as above amended, and the present
4 organization of the said Wiscasset Water Company is here-
5 by made valid, ratified and confirmed.
