STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ELEVEN.

AN ACT to incorporate the Wiscasset Electric Light and
Power Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. E. Fred Albee, H. W. Hawes, Charles L. Ma-
2 curda, Enoch Leathers, C. E. Emerson, E. S. Perkins, A.
3 W. Kierstead, W. G. Hubbard and A. H. Dodge, their
4 associates, successors and assigns are hereby incorporated
5 under the name of the Wiscasset Electric Light and Power
6 Company, for the purpose of making, generating, selling
7 and supplying electricity for lighting, heating, power, man-
8 ufacturing or mechanical purposes, in the town of Wis-
9 casset, in the County of Lincoln, or for the purpose of buy-
10 ing electricity from the Portland Power and Development

11 Company, a corporation located in the village of Damaris-
12 cotta Mills in said County of Lincoln, and selling such elec-
13 tricity for lighting, heating, power, manufacturing and me-
14 chanical purposes, in said town of Wiscasset, or for any
15 or either of such purposes, and for distributing, supplying
16 and selling electricity for any and all said purposes to any
17 corporation, firm or individual within said town desiring
18 to purchase the same, subject to the rights and liabilities
19 incident to similar corporations as fixed by the general
20 Statutes relating thereto.

Sect. 2. The capital stock of said corporation shall be
2 ten thousand dollars divided into shares of ten dollars each,
3 of such classes as the stockholders may determine, and it
4 may issue bonds for such amounts as may be required and
5 secure said bonds by mortgages upon the property and fran-
6 chises of the company.

Sect. 3. Said corporation is hereby authorized to con-
2 tract with any firm, individual or corporation for the pur-
3 pose of buying or selling power as the needs of its business
4 may require or permit.

Sect. 4. Said corporation is hereby authorized to set poles
2 and extend wires thereon in and through the streets and
3 ways in said town of Wiscasset, as it may deem most ex-
4 pedient in carrying out the purposes of Section one of this
5 act; also to extend its wires along and across the bridge
6 between Wiscasset and Edgecomb subject to such reason-

7 able restrictions as the authorities having the care of main-
8 tenance of such bridge may impose; and to set its poles
9 and extend its wires thereon in and along the roads and
10 ways in the town of Edgecomb in said County to such point
11 as to connect with the lines of said Portland Power and
12 Development Company, all subject to the same rights and
13 liabilities incident to similar corporations as fixed by the
14 general Statutes relating thereto.

Sect. 5. The first meeting of said corporation may be
2 called by written notice thereof, signed by any incorporator
3 herein named, served upon each incorporator by a copy of
4 the same in hand, at least seven days prior to the day named
5 therein for such meeting.
