IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ELEVEN.

AN ACT to incorporate the Rumford General Hospital.

Be it enacted by the People of the State of Maine, as follows:

20 cessors are hereby incorporated and made a body politic by
21 the name of the Rumford General Hospital, and by that
22 name sue and be sued, may have a common seal, and shall
23 have all the immunities and privileges and be subject to all
24 the liabilities of like corporations.

Sect. 2. Said corporation may take, receive, purchase, hold
2 and possess lands and tenements in fee simple or otherwise,
3 and dispose of and sell the same, and may receive of and
4 from all persons disposed to aid its benevolent purposes and
5 grants and devices of real estate, and any donations, sub-
6 scriptions and bequests of money, or other property, to be
7 used for the erection, support and maintenance of a general
8 hospital for the sick and injured to be located within the
9 town of Rumford.

Sect. 3. The said corporation shall have the power to make
2 and establish such by-laws and regulations as may be neces-
3 sary for the choice of proper officers, to prescribe their du-
4 ties and powers, and to provide generally for the internal
5 government and economy of the hospital, such by-laws and
6 regulations not being repugnant to the constitution and by-
7 laws of this state.
