### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to regulate fishing in the tributaries to Lake Sebasticook, so-called, in the town of Newport, in the county of Penobscot.

Be it enacted by the Pcople of the State of Maine, as follows: Section 1. In addition to the close season for fishing now

2 provided by the general law of the state, it shall be unlawful 3 to fish for, take, catch or kill any kind of fish at any time 4 from April first to July first of each year in Folsom stream,

- 5 so-called, a tributary to Lake Sebasticook, so-called, which
- 6 lake is situated in the town of Newport, in the county of
- 7 Penobscot, from the Woolen Mill Dam in Corinna to its
- 8 junction with said Lake Sebasticook, or in Stetson stream,
- 9 so-called, a tributary to said Lake Sebasticook, from the

10 lower mill dam in Stetson village to its junction with said Lake Sebasticook, or in any other tributary to said Lake Sebasticook in said town of Newport, or in that portion of Lake 3 Sebasticook lying north and east of a straight line drawn from Sandy point, so-called, on the east shore of said lake, in a north-easterly direction, to the Maine Central Railroad Company's culvert on the west shore, or in Durham Bridge 7 cove, so-called, or at any point within 600 yards from the 18 center of Durham bridge, so-called.

It shall also be unlawful for any person to have in posses-20 sion any kind of fish taken in violation of any provision of 21 this section.

- Sect. 2. Whoever violates any provision of this act shall be 2 subject to the same penalty as is provided in the general law 3 of the state for the illegal taking, catching or killing of trout 4 or land-locked salmon.
- Sect. 3. In all prosecutions arising under this act, munici2 pal and police courts and trial justices within their respective
  3 counties shall have, upon complaint, original and concurrent
  4 jurisdiction with the supreme judicial and superior courts,
  5 and all fines, forfeitures and penalties recovered by any per6 son for any violation of this act shall be paid forthwith by
  7 the person receiving the same to the state treasurer.
