STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND ELEVEN.

AN ACT to amend section one of chapter four hundred fifty of
the Private and Special Laws of 1907 entitled "An Act to
prohibit the throwing of sawdust and other mill waste into
Bog Brook and tributaries in the counties of Oxford and
Androscoggin."

Be it enacted by the People of the State of Maine, as follows:

Section 1. Amend section one of chapter 450 of the Pri-
vate and Special Laws of 1907 by striking out the last thir-
teen words of said section, viz: ("except that the pro-
visions of this section shall not apply to shingle waste")
so that said section, as amended, shall read as follows:

'No person shall cast or throw into Bog brook or any of
its tributaries, in the towns of Oxford and Hebron, in the
county of Oxford, and in the towns of Minot and Mechanic

9 Falls, in the county of Androscoggin, any sawdust, shavings,
 10 bark or other mill waste or place or deposit such sawdust,
 11 shavings, bark or other mill waste along the banks of said
 12 waters in such manner that the same shall fall or be washed
 13 into said brook or tributaries.'
