#### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to ratify and confirm the organization of Yarmouth Manufacturing Company, and to give said Company additional powers.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The organization of Yarmouth Manufacturing

- 2 Company, a corporation organized under the general laws of
- 3 the State of Maine, the certificate of organization of which
- 4 was filed in the office of the Secretary of State on the sev-
- 5 enth day of January, 1892, is hereby ratified and confirmed.

Sect. 2. Yarmouth Manufacturing Company shall have

- 2 all the powers specified in its certificate of organization, and
- 3 said Company is hereby authorized to engage in the general
- 4 business of making, generating, selling, distributing and sup-

- 5 plying electricity for lighting, heating, manufacturing or 6 mechanical purposes in the towns of Yarmouth, Cumberland 7 and Freeport; to control, own and operate by themselves, or 8 their lessees, any mill for manufacturing purposes, and to 9 supply the same with light and power.
- Sect. 3. Said Company is hereby authorized to construct, 2 maintain and operate its lines, upon, along and across the 3 highways, ways, streets, railroads and bridges in said towns, 4 and all necessary poles and conduits, and to enter upon and 5 dig up any road, street or way in said towns for the purposes 6 aforesaid, and in a general way to do any other act or things 7 necessary, convenient or proper to be done for the complete 8 establishment of its works and plants; provided always that 9 the said Company shall at its own expense, and to the satis-10 faction of the municipal officers of said towns, without un-11 necessary delay, repair said highways, streets and ways in 12 every part where they shall be so entered upon and dug up. 13 and restore the covering, pavement and sidewalk thereof, 14 respectively.
- Sect. 4. Said Company is hereby authorized to acquire by 2 purchase, lease or otherwise, but not however by any rights 3 of eminent domain, any and all necessary generated electric-4 ity, and to distribute the same, and to acquire by purchase, 5 lease or otherwise, but not however by any right of eminent 6 domain, any and all water privileges for the purpose of de-7 veloping, making, generating and distributing electricity for 8 the purpose of its incorporation.

Sect. 5. Said company is hereby authorized to acquire by 2 purchase, lease or otherwise, but not however by any right of 3 eminent domain, the property, capital stock, bonds, rights, 4 privileges, immunities and franchises of any corporation, 5 firm, partnership or individuals, engaged in the business of 6 manufacturing, generating, selling, distributing and supply-7 ing electricity for lighting, heating, traction, transportation, 8 manufacturing or mechanical purposes in the towns of Yar-9 mouth, Cumberland and Freeport, and upon such purchase, 10 transfer or lease, said company shall have the exercise and II enjoy all the location, powers, immunities, rights, franchises 12 and estates thus held and enjoyed by the corporation, firm, 13 partnership or individuals so selling or leasing, and shall be 14 subject to all the duties, restrictions, and liabilities, which 15 they, or any of them, shall be subject to by reason of any 16 charter, controlor general or special law.

Sect. 6. Said Company is hereby authorized to issue its 2 bonds for the construction and operation of its works, fund-3 ing its floating debt, or for the payment of money borrowed 4 for any lawful purpose, and to mortgage and pledge, as 5 security for the payment of the principal and interest of 6 such bonds, debts and loans, part or all of its property and 7 franchise.
