HOUSE AMENDMENT "A" TO SENATE DOCUMENT

NO. 170.

Page 8.

Amend Senate document No. 170, Bill, "An Act to incorporate moneys for the expenditures of government for the year one thousand nine hundred and eleven", by striking out the words, "eighty-seven thousand five hundred" and the figures "87,500.00", in the paragraph *For soldiers' pensions*, and inserting in their place the words "seventy-five thousand", and the figures '75,000.00', so that said paragraph shall read:

'For soldiers' pensions, as provided by chapter one hundred forty-five, sections one and two, Revised Statutes, seventy-five thousand dollars\$75,000.00.'

HOUSE AMENDMENT "B" TO SENATE DOCUMENT

NO. 170.

Page 10.

Amend Senate document No. 170, Bill, "An Act to appropriate moneys for the expenditures of government for the year one thousand nine hundred and eleven", by striking out the words, "sixty-three thousand nine hundred forty-five dollars and forty-four cents", and the figures "63,945.44", in the paragraph

For *Maine forestry district*, and inserting in their place the words 'sixty-seven thousand nine hundred twenty-two dollars and forty-six cents', and the figures, '67,922.46', so that said paragraph shall read:

'For Maine forestry district, as provided by chapter one hundred ninety-three, Public Laws of nineteen hundred and nine, sixty-seven thousand nine hundred twenty-two dollars and forty-six cents. \$67,922.46.'

HOUSE AMENDMENT "C" TO SENATE DOCUMENT
NO. 170.

Page 16.

Amend Senate document No. 170, Bill, "An Act to appropriate moneys for the expenditures of government for the year one thousand nine hundred and eleven", by striking out the words, "For the purchase of intoxicating liquors, as provided by chapter two hundred fifty-two, section one, Public Laws of nineteen hundred and nine, fifty thousand dollars," and the figures, "50,000."

HOUSE AMENDMENT "D" TO SENATE DOCUMENT
NO. 170.

Page 16.

Amend Senate document No. 170, Bill, "An Act to appropriate moneys for the expenditures of government for the year one thousand nine hundred and eleven", by striking out the words, "thirty-seven thousand five hundred", and the figures "37,500.00", in the paragraph, *State of Maine Cattle Commission*, and inserting in their place the words 'twenty-five thousand', and the figures '25,000.00', so that said paragraph shall read:

'For prevention of contagious diseases among horses and cattle, as provided by chapter nineteen, section ten, Revised Statutes, as amended by chapter one hundred thirty-three, Public Laws of nineteen hundred and nine, twenty-five thousand dollars. \$25,000.00.'

HOUSE AMENDMENT "E" TO SENATE DOCUMENT
NO. 170.

Page 23.

Amend Senate document No. 170, Bill, "An Act to appropriate moneys for the expenditures of government for the year one thousand nine hundred and eleven", by striking out the words, "eighty-four thousand five hundred sixty-seven dollars and eight cents", and the figures, "84,567.08", in the last two lines of section one, and inserting in their place the words, 'thirteen thousand five hundred forty-four dollars and ten cents' and the figures, '13,544.10', so that said paragraph shall read:

'Amounting to the sum of one million six hundred thirteen thousand five hundred forty-four dollars and ten cents. \$1,613,544.10.'
